Question

With respect to the CPTPP, is DFAT aware of other Parties having entered into side letters with each other but not Australia?

Answer

In the context of the Comprehensive and Progressive Agreement for Trans-Pacific Partnership (CPTPP), a number of Parties agreed side instruments/letters with a number of other Parties on a range of issues. Side instruments/letters between Parties that do not include Australia do not affect Australia's implementation or benefits under the CPTPP.
