We are pleased to provide you with the following <u>information</u> regarding the <u>functioning and</u> activities of the Committee on Petitions (PETI) of the European Parliament.

The objective of the <u>petitions process</u> in the European Parliament is to ensure that all European citizens and residents have the opportunity to communicate with Parliament and exercise their right to petition, which is one of the fundamental rights enshrined both in the Treaty and in the Charter of Fundamental Rights. The petitions allow Parliament, through its PETI Committee, to conduct an ongoing reality check on the way in which European legislation is implemented and measure the extent to which the EU institutions are responding to citizens' concerns. The objective of the PETI Committee is to provide a response to all petitions and, when possible, a non-judicial remedy to legitimate concerns on issues related to the EU fields of activity raised by petitioners.

<u>Petitions can be submitted</u> electronically or in 'paper' form. Information on how to submit a petition can be found in the <u>Petitions Web Portal</u>:

https://petiport.secure.europarl.europa.eu/petitions/en/home. The section on FAQs (frequently asked questions) provide useful information concerning eligibility and requirements, treatment and follow up, as well as registration and submission.
