Thank you, Ms Beauchamp. Would you care to table your opening statement for the committee?

Answer:

I thought it might be useful for the committee to understand the role of the Office of the Coordinator-General and, in particular, where we fit within the Department of the Prime Minister and Cabinet.

The Department of the Prime Minister and Cabinet has been called separately, but I wanted to clarify that I am actually the Deputy Secretary, Governance in the Department. The Office of the Coordinator-General is a division within the department. I will explain the governance arrangements and the roles and responsibilities, because they are germane to some of the questions and clarifications that the committee may be seeking.

Following the announcement by the Prime Minister of the Nation Building and Jobs Plan on 3 February 2009, the Prime Minister, premiers, chief ministers and the president of the Local Government Association together with Commonwealth, state and territory treasurers, were all involved in a special Council of Australian Governments (COAG) meeting on 5 February 2009. It was at this meeting that it was decided to introduce new implementation and monitoring arrangements for the Nation Building and Jobs Plan. A significant aspect of those arrangements was to maximise the timely and effective delivery of the stimulus projects.

COAG resolved to introduce new implementation and monitoring arrangements, which included the establishment of an oversight group involving centralised Coordinators-General. It also resolved to establish line department coordinators at the Commonwealth and state levels. These arrangements were formalised in the Nation Building and Jobs Plan National Partnership Agreement.

The role of the Commonwealth Coordinator-General, with the cooperation and assistance of State and Territory Coordinators-General is to:

- Ensure programs being implemented meet targets as outlined in the National Partnership Agreement;
- Monitor expenditure and roll-out of deliverables;
- Work with states and territories to solve implementation problems that arise in the delivery against COAG milestones; and
- Report to COAG and ministers on these issues.

The Office of the Coordinator-General was established within the Department of the Prime Minister and Cabinet in February 2009 following the agreement from the COAG meeting. For clarification, in terms of implementing the programs, it was very clear both in the COAG communiqué from that meeting and in the subsequent budget papers around the Nation Building and Jobs Plan as well as the Economic Stimulus Plan that line agencies have responsibility for program design and delivery and received funding to undertake that role. The line agencies report to individual ministers and liaise with the Office of the Coordinator-General regarding implementation and progress against milestones.

The Office of the Coordinator-General has worked with the Department of the Environment, Water, Heritage and the Arts in the rollout of the Home Insulation Program, including ensuring that the objectives agreed at the COAG meeting on 5 February 2009 were being met and supported. That clarification is very important in understanding the role of the Commonwealth, the role of the states and territories and the role of the line agencies in the governance arrangements that were put in place.

COAG endorsed the Energy Efficient Homes Package to modernise Australian homes, resulting in the plan to install ceiling insulation in up to an additional 2.7 million uninsulated Australian homes. To complement this program, it was also agreed that the States would maintain existing energy efficiency funding levels, and re-direct state funding for other energy efficiency programs such as insulation programs to home energy advice programs, particularly for the most disadvantaged households. Advice programs, such as home energy audits, were to help households to maximise the benefits of their new insulation and further reduce their energy costs.

States additionally agreed to audit the energy efficiency of their existing public housing stocks, and consider implementing a program for cost-effective upgrades.

It was further agreed to examine and resolve additional measures that were to be drawn from the report of the Energy Efficiency Sub-Group of the COAG Working Group on Climate Change and Water to build on the Energy Efficiency Homes package and further improve the energy efficiency of residential and commercial buildings across Australia:

- significantly increase energy efficiency requirements for all classes of commercial buildings in the Building Code of Australia from 2010;
- ensure greater consistency in the application of building standards across all States;
- phase-in mandatory disclosure of the energy efficiency of commercial buildings and tenancies from December 2009;
- increase energy efficiency requirements for new residential buildings to six stars, or equivalent, nationally by 2010; and
- introduce mandatory disclosure of residential building energy, greenhouse and water performance at the time of sale or lease by 2010.

The use the Commonwealth's on-line portal was also agreed as a single point of inquiry for all energy efficiency programs for households and businesses, and that a key part of the COAG National Energy Efficiency Strategy be a commitment from Commonwealth and State governments to improve the energy efficiency of their own operations. States also re-committed to expediting the national roll-out of electricity smart meters, agreed by COAG in April 2007.

disclosure may unreasonably breach the privacy of individuals.



Highlights and Potential Issue

- The take up of home insulation has increased substantially with a further 160,000 claims received in October 2009.
- The majority of funding for insulation has been paid against claims from NSW (43%) and Queensland (34%) and for solar hot water claims primarily claims from NSW (66%).
- The data for Solar Hot Water Applications Received shows a significant reduction on previous months' figures. DEWHA advise that early data was inflated due to double counting.
- Complaint levels have been low, tracking at less than 0.5%
- At end October around 9,000 businesses are registered with over 7,000 actively submitting claims.
- On 2 November 2009 changes to the insulation program were announced reducing the rebate cap to \$1,200 and issuing revised guidelines which provide a greater focus on safety and compliance.





Highlights and Potential Issues

- The take up of home insulation has increased further with ove 200,000 claims received in November 2009 (this is expected to reduce into January with the new measures coming into effect on 1 December 2009)
- The majority of funding for insulation has been paid against claims from NSW (43%) and Queensland (32%) and claims for solar hot water primarily coming from NSW (66%).
- 9,820 installers are registered, as at 26 November 09
- The high take-up rate of the insulation program indicates that funding will be exhausted earlier than anticipated – it is too early to gauge the impact on demand that the two quote requirement and reduced rebate will have.
- 86% of Solar Hot Water applications received has been paid and applications rates remain high.





Hi Mlke,

Comment on the registration of insulation installers follows. I will respond separately on Cleve School.

- (a) South Australia has a requirement for insulation installation to be undertaken by licenced installers. This pre-dates the Nation Building Economic Stimulus Plan initiatives. Any person or business seeking to install or retrofit insulation in South Australia, whether under the rebate program or otherwise, must be licensed under the *Building Work Contractors Act 1995*. They must have (1) a building work contractors licence which includes insulation within its scope; and (2) the person or business must also nominate a registered supervisor/s who will be present for all work and who has insulation in their scope of competencies. The licensing requirements apply to both principal contractors and sub-contractors. Any plumbers or electricians seeking to diversify their businesses to include retrofitting insulation, and who are currently separately licensed under the *Plumbers Gas Fitters and Electricians Act 1995*, must also apply for a building work contractor licence and supervisor registration as outlined above. Licensing is managed by the SA Office of Consumer and Business Affairs (OCBA).
- (b) As at the beginning of June 2009, of the 96 installers who had indicated their interest as part of the Australian Government's pre-registration process, only 40 have relevant licensing in SA. The balance (56) would essentially be "new entrants" requiring licensing. A further influx of license-related applications (contractors and supervisors) may be expected following the Australian Government's planned broad-scale communications (ads, forums and more) through June and July 2009.
- (c) My Coordinator General office has been working closely with OCBA since the announcement of the insulation rebate program to determine opportunities to streamline and fast-track licensing processes in SA for insulation installers to maximise early rollout capacity and job/stimulus creation in SA. A typical license application for building work currently takes about 6-8 weeks (not the 6 months indicated in the issue raised with your office). By instituting fast-track mechanisms, OCBA is expecting this period could be reduced to under a month and possibly less (where scope of work is limited to insulation). This includes completion of any necessary insulation course. Fast-tracking mechanisms include:
 - 48 hour turnaround to verify that those seeking to enrol on the Australian Government's register, and nominating SA as their geographic area of work, have appropriate licensing in SA. Those not having appropriate licensing will be diverted to a fast-track process developed specifically for ceiling insulation installers
 - An additional 2 dedicated licensing officers to March 2010 to deal with the expected influx of ceiling insulation-related applications during rollout of the program

- "Priority service" negotiated with SA Police Department for national police certificates (licensing requirement)
- Creating a new endorsement for building work contractor licences which can be limited to "ceiling insulation" only. This will confine the competencies necessary to be demonstrated and speed assessment. It does not prevent the applicant seeking a broader scope of work if they choose to, either initially or at a later time.
- Removing the need to demonstrate the \$8,000 minimum asset base in order to obtain
 the building work contractor licence where scope is limited to ceiling insulation only.
 Any risk associated with removing this requirement is countered by the Australian
 Government's requirement for registered installers to have appropriate insurance.
- Seeking formal recognition by the Commissioner for Consumer and Business Affairs
 of the competencies relevant for insulation installation, to both support the new
 restricted endorsement, and to ensure that competencies for licensing align with the
 Australian Government's registration requirements.
- Working directly with the Master Builders Association of South Australia (MBASA) to
 ensure availability of insulation installation courses for license applicants from June
 2009, both in metropolitan and regional areas. This does not prevent other registered
 training organisations from taking up or delivering the course competencies, but
 ensures capacity for fast rollout and accessibility, as well as ability to
 schedule additional courses to meet demand as necessary. MBASA's role would
 include:
 - default provision of insulation installation competencies, particularly during the June to August period to service the initial influx of new licensing applicants
 - default/dedicated provision of the course in regional areas based on demand collated by OCBA through the licensing process
 - developing and managing simulated practical assessment (alternative to onjob assessment) to speed course completion and attainment whilst maintaining robustness of that assessment e.g. building of in-situ roof spaces which are also portable to regional areas
 - working directly with the Construction Industry Skills Board of SA to gain recognition of the insulation installation course for training subsidy purposes (this is unique to SA and has capacity to provide up to 50 per cent or more of the cost of training for applicants).
- (d) I am aware that the SA State Coordinator for the insulation program has made representations to his Commonwelath counterparts about support for fast-tracking of licensing processes in SA. His proposal also includes an integrated model for communications, complaints, investigations, auditing and enforcement related to the insulation program in SA. This is subject to further discussion between the parties.
- (e) A further model is currently being developed to ensure "hard to get" households and markets in SA are serviced by the insulation program (i.e. rental, low income, special needs, and remote). This includes an initial trial for Northern Suburbs areas of Adelaide and targetted rollout across the State. This is intended to maximise penetration of insulation (and hot water rebates) in these markets as well as further job creation/stimulus with a focus on transitioning

Answer:

There have been significant changes to the Home Insulation Program Guidelines since being first issued in early 2009. Each time the requirements for the training and competency of installers were increased and tightened.

The Department of the Prime Minister and Cabinet has been advised by the Department of Environment, Water, Heritage and the Arts of the key changes including:

Timeline of changes in standards

Phase 1: Early Installation

Between 3 February 2009 and 30 June 2009

Interim guidelines were issued (*Early Installation Guidelines*) which required insulation:

- a) be installed by the owner or employee of a registered business (with an Australian Business Number) operating in the installation of thermal insulation;
- b) be installed to various Australian Standards and comply (as a minimum) to a specified R-value;
- be new ceiling insulation material installed in an existing dwelling (not an extension or a new dwelling covered by mandatory thermal performance requirements for new housing under the Building Code of Australia); and
- d) be installed in the householder's principal residence.

There were no specific training or competency requirements.

Householders were not allowed to install their own insulation. Insulation had to be installed by suitably trained and experienced installers or under close supervision.

Government housing was not eligible for assistance under the Program.

From 1 July 2009

Under relevant laws, installers have obligations and a duty of care to their employees, contractors and sub-contractors to provide a safe work environment, safe systems of work, and adequate training and supervision.

Installers were required to comply with minimum competency requirements and those who failed to provide evidence of minimum competency were not eligible to participate.

The Guidelines mandated insulation be installed by an installer listed on the Program's Installer Provider Register:

- a) OHS induction training required for all installers.
 - This is evidenced by:
 - OHS induction card OR
 - o White Card OR
 - Statement of attainment from an Registered Training Organisation (RTO) against CPCCOHS1001A Work Safely in the Construction Industry.
- b) Business/ Installer was required to provide evidence of 1 of 3 competencies and ensure every installer was supervised by a person who had one or more of the following:
 - A relevant trade qualification; or
 - · Completed insulation installation training;
 - Have 2 years prior experience in installing insulation.

To register on the Installer Provider Register, installers were required to provide the following information:

- a) The name of the organisation which must be a "legal entity", i.e. a registered company, incorporated association or body corporate established by statute or the name of an individual, including trading name(s);
- b) The Australian Business Number of the organisation;
- c) Contact details; and
- d) The geographical area where insulation installation services would be provided.

Installers had to also:

- a) provide proof that they met the minimum competency standards including state and territory requirements;
- b) provide proof that the specified insurance was held;
- c) accept the Terms and Conditions of Registration.
