RESPONSES TO QUESTIONS ON NOTICE:

Dairy Australia from public hearing in Melbourne on Australia's trade with Middle East on 17 October 2014

1. Halal - cost of certification - Middle East markets.

The GCC is forecast to consume US\$43.8 billion worth of Halal food products in 2009. The predominant markets for Halal products in the Middle East are the GCC countries. Australian exporters have a number of certifying organisations that are recognised by Middle Eastern countries. Exporters advise a fixed cost of between \$3,000 to \$5,000 for the Halal certification service.

2. Agricultural Counsellors - practical examples of assistance.

Australia currently exports dairy products to more than 100 countries at a value of \$2.7 billion a year. Market access issues in the form of technical barriers to trade have a negative impact on both the volume and value of dairy products traded.

In 2013/2014 Dairy Australia commissioned Economic and Agribusiness Consultants David Harris and Associates to undertake a comparative evaluation of technical barriers to trade for the Australian dairy products. The study reviewed the technical requirements of import markets and identified technical barriers to trade (TBT's). A comparison of these, and an estimate of the impact to industry in value terms was carried out in order to prepare composite rankings of the TBT's to guide reform priorities. The project examined nine separate product categories across eleven categories of technical requirements along the supply chain.

The primary function of the Department of Agriculture's, Agricultural Counsellor program is to maintain market access for agricultural exports such as dairy and to overcome the current technical barriers to trade that exist. Agricultural Counsellor posts play a major role in Australia's efforts to: remove or lower market access barriers for agricultural products; facilitate trade; monitor emerging international issues; help resolve quarantine issues; and, provide briefings and assist with visiting delegations.

Where Department of Agriculture, Agricultural Counsellors are located in markets, they can more effectively engage directly with local officials/government representatives to address

access issues as they arise, and work proactively to identify and prevent non-tariff barriers affecting dairy imports.

As well as representation in key markets, representation in key competitor countries is also of benefit. Given the role of the EU and the US as agricultural policy setters, on-the-ground representation for Australia means issues can be addressed before they develop. Moreover, in the case of the EU, the Commission is reluctant to engage directly with industry so government representatives are needed as facilitators. A case in point has been consultations on Geographical Indications (such as those on Danbo and Gouda Holland).

A total of 356 TBT's were identified by the report by David Harris and Associates with 141 of these being deemed to be significant in their impact to trade. Of these, 32 were in South East Asian markets and 20 in North Asia, 50 were in the Middle East and 21 in Central Asia, 2 were in North America and 16 across other markets.

Market impacts have been aggregated to present a regional perspective. This shows TBT's have an impact of \$398 million in the Middle East. The total value of all TBT impacts is \$1.57 million.

The most significant dairy TBT relating to the Middle East is an inconsistency with respect to date marking of dairy products. Qatar have sort, through the SPS notification process, to apply mandatory date marking of some dairy products which are shorter than those applied by other GCC countries.

Specifically:

- Full Cream Milk Powder/ Instant Full Cream Milk Powder acceptable shelf life is 24
 months in all GCC markets except Qatar where it is 12 months. We would like it to be
 standardised to 24 months across GCC.
- **Butter (Unsalted)** acceptable shelf life is 24 months in all GCC markets except Qatar where it is 18 months. We would like it to be standardised to 24 months across GCC.
- **Ultra-High-Temperature milk in tight sealed carton** acceptable shelf life is 6 months in all GCC markets. We suggest that this be extended to 9 months.

The dairy industry does not support the setting of mandatory expiration periods, as manufacturers are best placed to determine the most appropriate expiration dates to achieve the required safety and quality requirements, based on the composition, processing and packaging of their specific products.

The setting of defined periods does not take into consideration these factors. For example in the draft standard under '4.4.1 Chilled Food Products: To be stored at a temperature from $0^{\circ}\text{C} - 5^{\circ}\text{C}'$ expiry periods for pasteurized milk and heat treated milk (UHT) are defined at 5 days and 6 months respectively. As outlined in the attached article, pasteurized milk shelf life can be as long as three weeks, while advances in technologies mean Extended Shelf Life milk products with shelf life far beyond traditional pasteurized milk are now available. The article also defines the many different factors that affect shelf life, including storage

temperature, thermal treatment parameters, raw milk quality and post pasteurization contamination. A manufacturer is best placed to understand how these factors work together to determine shelf life. With the correct processing, manufacturers can achieve UHT shelf life of 9 months or more.

Furthermore UHT milk is a shelf stable product, yet is currently included in the 'chilled food products' section. Apart from these UHT products, the coverage of the mandatory standard appears to be for 'higher risk' products, including chilled products, baby food products, food products which need specific temperatures for keeping and fresh foods and seafoods. Lower risk shelf stable products, including UHT milk, should be covered in the voluntary standard not the mandatory standard.

Similarly the voluntary standard includes a range of guideline expiration periods for dairy products, including ranging from 12-18 months for milk powders. The actual shelf life of milk powders is dependent on a range of factors including packaging, the physical state of the lactose and other carbohydrates, water activity and temperature. Again a manufacturer is the best placed to understand how these factors work together to determine shelf life. Australian manufacturers can achieve shelf life of 24 months or more for full cream dried milk.

3. Cost of tariffs for Australian product into Middle East

In 2012 it was estimated that Australian dairy exporters paid around \$13.5 million in tariffs to Gulf Cooperation countries.

Duties and Taxes

- * Sales tax at various rates, levied on the duty-paid value, is levied on most products, whether imported or domestically produced. Rates of 10% to 20% apply to most goods.
- * Customs Surcharge:
 - 2% of the value of the consignment for commodities with duty rates between 5% and 30%
 - 4% of the value of the consignment for commodities with duty rates above 30%.

Labelling and Packaging Requirements

- * Goods should be securely packed, having due regard to the nature of the good, means of transport and likely climatic conditions during transit and delivery.
- * Outer containers should bear the consignee's mark and port mark should also be numbered (to accord with the packing list) unless their contents can be otherwise readily identified.
- * Specific regulations apply the labelling of foodstuffs. Labels must be in Arabic (foreign languages may also feature) and must indicate the following:
 - Name and address of the manufacturer including country of origin
 - Details of the product including the name, quality and ingredients in proportions (including additives and preservatives)
 - Production and expiration dates.
 - Storage and usage instructions
 - Net and gross weight
 - The name and address of the importer
 - The phrase Islamic Slaughter on packages containing animal products (except seafood)

Food Standards and Laws

- * Livestock, animal products, plants and plant products are subject to strict health controls.
- * The precise chemical composition of food additives and other materials used in food processing must be provided by the competent inspection services in the exporting country.
- * Edible oils and greases (of either animal or vegetable origin), processed tomato products, molasses, salt and soap must conform to specific quality standards. Butter and butter substitutes must not contain boric acid or other injurious preservatives.
- * Imported foodstuffs, meat, oils and fats, live animals, seeds, seedlings and crops for human consumption, animal feeds, milk substitutes and tobacco are subject to radiation inspection.

Labelling and Packaging Requirements

- * Gulf Standard 9/2007 governs food label requirements and 150/2007 governs shelf life requirements. Under this standard, the food label must include on the original label or primary packaging the following information:
 - Product and brand name
 - Ingredients and additives, in descending order of proportion
 - Net content in metric units (volume in case of liquids)
 - Manufacturer's name and address
 - Country of origin
 - Origin of animal fat (e.g. beef fat)
 - Dates of production and expiry
 - Instructions for use (if any)
 - Special storage, transportation and handling instructions
 - Lot identification
- * Original labels must be printed in Arabic, but exceptions do exist. For example, bilingual labels are permitted, provided one of the languages is Arabic (e.g. Arabic/English). In addition, Arabic language stickers are permitted in lieu of Arabic or bilingual labels, provided the sticker:
 - Is extremely difficult to remove
 - Includes all label information
 - Does not cover the original label, and
 - Does not contradict information on the original label
- * Labels for specialty foods, such as diet, health and baby foods, must contain detailed information about the product's vitamin and mineral contents, nutritive value per 100 grams and proper use and storage.
- * Packing should be strong and should guard against extreme heat in summer, humidity in winter, and possible brief periods of storage in the open.

Food Standards and Labelling

- * As a group, the GCC is striving to create a common set of food standards, with the Saudi Arabian Standards Organization (SASO) as the lead agency.
- * Saudi standards are based mainly on CODEX Alimentarius regulations and to some extent on European and U.S. standards but modified to reflect local conditions. More information can be found at www.saso.org.sa
