Written Question on Notice

Senator Paul Scarr:

Please provide the committee with:

- a) information on the *number* of Australian women and children who have been reported as missing, disaggregated by state/territory and year (1980 - present if available).
- b) information on the *number* of First Nations women and children who have been reported as missing, disaggregated by state/territory and year (1980 present if available).
- c) information on the *number* of non-First Nations women and children who have been reported as missing, disaggregated by state/territory and year (1980 present if available).
- d) Information on the rate of:
 - i. First Nations women and children,
 - ii. non-First Nations women and children,
 - iii. Australian (both First Nations and non-First Nations) women and children, and
 - iv. all Australians

who have been reported as missing, disaggregated by State/territory and year (1980-present if available).

e) If you are unable to provide this information, please explain the reasons for not being able to do so (e.g. certain data isn't collected in a particular state/territory, or isn't captured by your agency etc.). Are there other sources that may reliably record this information? If so, what are they?

Answer:

The AFP, as host of the National Missing Persons Coordination Centre (NMPCC), has consolidated data received from State and Territory police on the number of Australian women and children who have been reported missing (**Attachment A** refers).

The table at **Attachment A** has been collated from data received by the AFP from annual reports from the State and Territory police agencies for the **calendar years 2019, 2020 and 2021**. Prior to this time, the AFP did not receive information relating to Aboriginal and Torres Strait Islander missing person reports. The information provided for States and Territories includes total numbers of missing persons broken down into categories such as age, gender, Indigenous status, whether an Amber Alert was issued etc.

The AFP is not in a position to provide information on the rate of women and children who have been reported as missing due to inconsistent data collection across state and territory police.

The AFP consulted all relevant agencies on the release of this information to the Committee for the purpose of this inquiry. South Australia Police is providing its data in response to a separate Committee request, and has requested its information be excluded from AFP's response.

The AFP cannot attest to the data as a complete and accurate data source because:

- a) The data is provided by individual State and Territory police agencies, at their discretion, and is reliant on data quality and business processes within each jurisdiction;
- b) There are differences in approaches across jurisdictions which lead to inconsistent data reporting. For example:
 - In mid-2018, one agency began only placing those missing more than 7 days on their database. Therefore the 2018 data is not an accurate reflection of those reported missing in 2018. This approach was subsequently changed.
 - The way data was extracted in 2021 by one agency was different to what was undertaken in previous years, therefore there is a disparity between other years.
 - One agency utilises one report per child to record and manage children in care that repeatedly go missing from their placement. The number of missing juvenile incidents is therefore significantly greater than the reports. One particular child had 1 report but 80 missing incidents reported to police.

The AFP continues to work with all state and territory police to ensure to the extent possible, data is collated consistently. This data collection is outside the national data collections programs conducted by the Australian Bureau of Statistics. As can be seen from the information above, there has been improvements. All jurisdictions are aspiring to provide data that meets the agreed **Missing Persons Minimum Dataset** (attached). This includes demographics, information on the missing event, recidivism rate, risk factors and case finalisation.
