**COMMUNITY CONSULTATION REPORT FOR THE CONSTRUCTION OF THE  
ENHANCED GAP CROSSING CAPABILITY FACILITIES FOR THE LAND 155  
INFRASTRUCTURE PROJECT**

This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) of the nature and extent of community consultation as part of LAND 155 Construction of Enhanced Gap Crossing Capabilities Facilities Project (the Project).

The objectives of the community consultation undertaken by Defence were to ensure that the community:

- a. Was well informed about the Project by using effective and proved communication channels to convey details of the proposed works; and
- b. Had every opportunity to raise issues of concern so that wherever feasible they could be addressed by Defence in its program of works.

The consultation activities undertaken included:

- a. Letters advising the nature and locations of proposed works and offer for individual briefings being sent by email and receipt confirmed by telephone to the Sandy Point Progress Association, State and Federal members as outlined at Annex A. An example of the correspondence sent to the members and group on 03 March 2017 via email is provided at Annex B;
- b. Advertisements in local and federal newspapers, as detailed and listed at Annex C;
- c. Leaflets drops to residents near the works at Lavarack Barracks and Camp Sapper advising them of the works, website for further details and Public Information Sessions. Locations of the leaflet drops and an example of this correspondence is detailed at Annex D;
- d. Public Information Sessions were undertaken for the works at Lavarack Barracks and Camp Sapper as detailed at Annex E;
- e. Provision of a project specific website, <http://www.defence.gov.au/id/Land155>; and
- f. Provision of a project specific email to receive community feedback, [LAND155@ghd.com](mailto:LAND155@ghd.com).

Key issues raised by the community at the Community Consultation Sessions and the responses provided by Defence are outlined at Annex F.

In conclusion, no significant issues have been identified during Defence's community consultation that will impact on the proposed works. Defence is satisfied that it has taken all reasonable steps to inform the community about the project and to provide opportunities for the community to raise concerns.



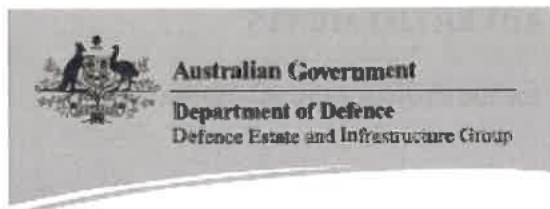

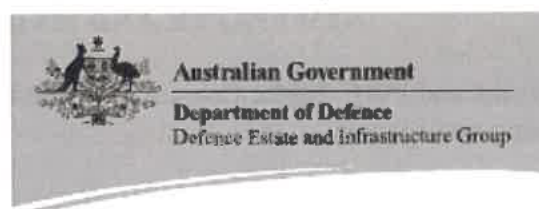
