Senate Finance and Public Administration References Committee Opening Statement on Senate Order Reporting Rationalisation

Ms Jan Mason, Deputy Secretary, Business, Procurement and Asset Management, 9:00am, 14 February 2014

- We're appearing before you today to discuss how AusTender provides a robust mechanism for public reporting of procurement contracts.
- Both Commonwealth-wide policy and agency cultures reflect a pro-disclosure approach to contracting. As such, we believe the Senate Order has achieved its objective of shedding light on the use of confidentiality clauses in government contracts.
- Consolidating the reporting requirements would see a decrease in reporting complexity, removal of red tape and a reduction in the administrative burden and costs placed on agencies.
- This has been an area of consistent advice across a number of ANAO audits.
- Our views towards rationalisation not only reflect our confidence in the AusTender system, but its use as an accountability mechanism outside of agencies. For instance, AusTender is visited more than 1 million times each year.
- An option that the Committee may like to consider in enhancing the reporting process is for AusTender to generate a Senate Order listing on the behalf of agencies. This would provide agency listings collectively, rather than separately on individual agency websites.

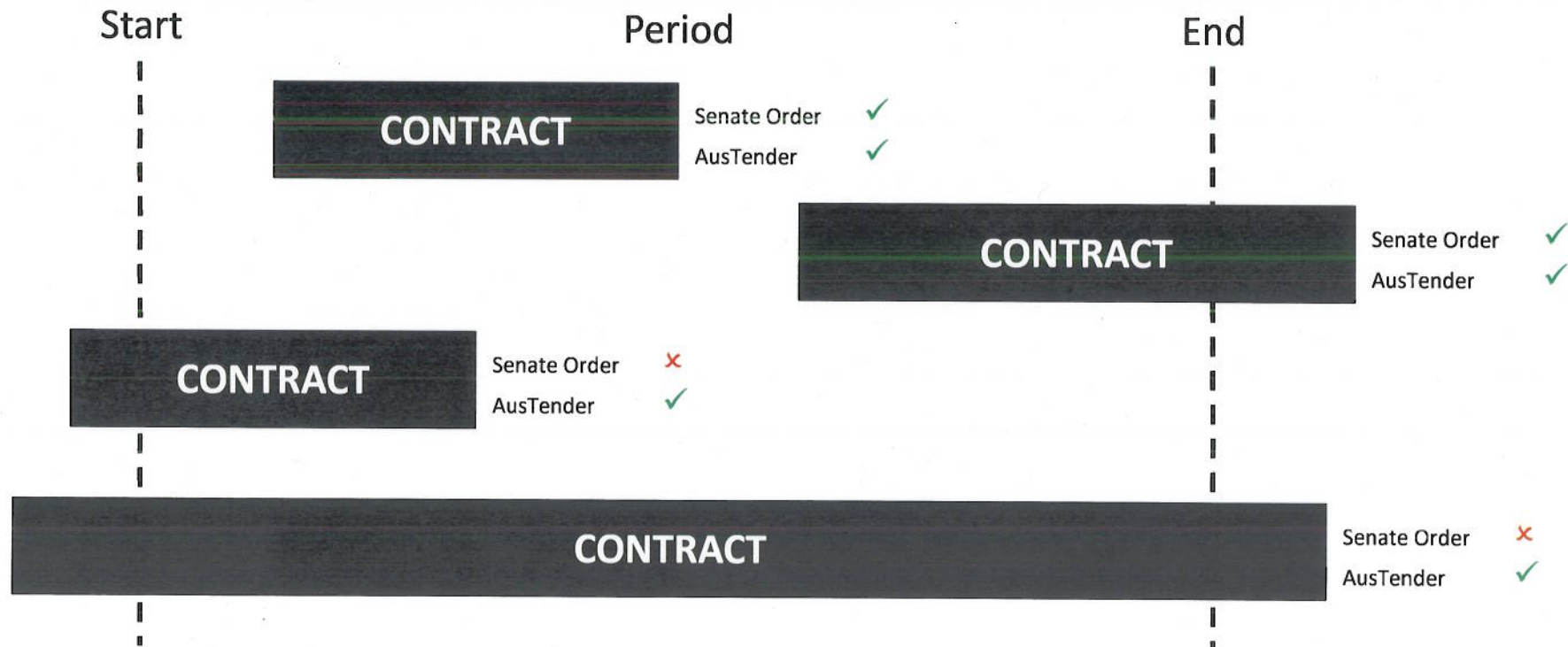
- ❑ 1990's – *Annual Reports* consultancy contracts \$10,000 and greater

- ❑ 2007 – *AusTender* the Commonwealth Procurement Guidelines/Rules (CPGs/CPRs), contracts \$10,000 and greater

This has led to complexity

- An agency signs a consultancy contract in August for \$120,000 with an option of additional work valued at \$60,000. The option was exercised in May, and \$10,000 was spent before the end of the financial year.
- The amount reported for this contract would be:
 - \$180,000 on AusTender
 - \$120,000 in the calendar year Senate Order Listing
 - \$180,000 in the financial year Senate Order Listing
 - \$130,000 in the Annual Report (reporting aggregate expenditure)



Advantages of AusTender

- ✓ centralised public disclosure at time of contract commitment
- ✓ timely information – no waiting on static reporting
- ✓ dynamic updating of information
- ✓ information is searchable and can be downloaded
- ✓ full financial commitment reported at the time of award
- ✓ confidentiality identified for all reported contracts – no \$100K threshold
- ✓ supports cross-agency, cross-year, sectoral and aggregate reporting
- ✓ AusTender is in widespread use as the key transparency mechanism to support public scrutiny

- ✓ Agencies have instituted processes and procedures to quality assure their contract data
- ✓ Central Help Desk support for agencies, suppliers and the public on both policy and the use of AusTender
