The Forum of Australian Services for Survivors of Torture and Trauma (FASSTT) welcomes the opportunity to provide this submission to the Inquiry into the Australian Citizenship Amendment (Citizenship Test Review and Other Measures) Bill 2009.

In particular, FASSTT commends the inclusion of a provision that certain applicants may be eligible for citizenship without sitting the citizenship test if, at the time of application, they have a physical or mental incapacity that is as a result of suffering torture or trauma outside Australia.

As the Citizenship Test Review Committee noted, the experience of torture and trauma may have a "severe impact on (survivors') ability to retain and recall information." FASSTT affirms this on the basis of its considerable experience providing specialist torture and trauma rehabilitation services to people from refugee or refugee-like backgrounds throughout Australia. FASSTT agencies collectively deliver services to approximately 13,000 people each year.

While individuals so affected may be unable to pass a formal test, they are not incapable of understanding and respecting the responsibilities of citizenship. To exclude them from the rights of citizenship is profoundly unfair.

FASSTT recommends that the Senate Standing Committee on Legal and Constitutional Affairs endorse the amendment.
