Inquiry into Energy Efficient Homes Package

I refer to the committee's inquiry into the Energy Efficient Homes Package (ceiling insulation).

On 26 February and 25 March 2010 the committee heard evidence from officers of the Department of the Prime Minister and Cabinet concerning the role of the Office of the Coordinator General in overseeing the Home Insulation Program.

The committee notes 39 responses which the Department provided.

However, the committee considers a number of the responses to be unsatisfactory. For example, some responses cite Cabinet confidentiality in an attempt to justify the non-provision of basic information about the number and dates of reports to Cabinet or Cabinet Committees (see Questions on Notice 22 and 32). A full list of responses the committee considers to be unsatisfactory is enclosed.

The committee has resolved to invite you to appear before it to provide further information in these areas where the committee considers unsatisfactory responses have been provided, and to provide a progress report on actions since the committee's last hearing of 25 March relating to the closure of the Home Insulation Program, and in particular payments to installers.
