#### **Question:**

The Prime Minister announced that Catherine Tanna would be stepping down from the Commission to avoid conflicts of interest.

1. On what date will Catherine Tanna finish with the Commission?
2. What is the conflict that the Prime Minister was referring to when he announced that she was stepping down?
3. Please provide the Committee with a copy of the Conflict of Interest declarations?
4. Will EnergyAustralia stand to benefit from any of the recommendations of the Commission?
5. On the 4 June hearing it was raised that Catherine Tanna had a role in inviting members to join the Manufacturing Taskforce.
  - a. Who did she invite?
  - b. What was the process for selecting these members?

#### **Answer:**

1. Ms Catherine Tanna's last Board meeting was on 12 August 2020.
2. The Prime Minister, the Hon Scott Morrison MP, thanked Ms Tanna for her contribution to the National COVID-19 Commission Advisory Board (NCC) and noted her role with EnergyAustralia.
3. NCC members' declarations are provided in confidence and contain sensitive personal information related to themselves and members of their immediate families. The disclosure of this information may unreasonably infringe the privacy of the individuals concerned.
