## Education and Other Legislation Amendment (Abolishing Indexation and Raising the Minimum Repayment Income for Education and Training Loans) Bill 2022

This letter outlines Independent Higher Education Australia's (IHEA) feedback regarding the Education and Other Legislation Amendment (Abolishing Indexation and Raising the Minimum Repayment Income for Education and Training Loans) Bill 2022 (the Bill).

## Who we are

IHEA is the peak body representing most of Australia's independent higher education providers with campuses across Australia. IHEA members have different missions, scales and course offerings across the full Australian Qualification Framework (AQF) range (Diplomas to Doctorates). IHEA members comprise:

- Four private universities (Bond University, Torrens University, University of Divinity, Avondale University);
- Three University Colleges (Alphacrucis University College, Moore Theological College, and Australian College of Theology); and
- 68 not-for-profit and for-profit Institutes of Higher Education.

IHEA members teach 74 percent of the students in the independent sector (i.e., more than 125,000 students) and educate students in a range of disciplines, including law, agricultural science, architecture, business, accounting, tourism and hospitality, education, health sciences, theology, creative arts, information technology, and social sciences. IHEA's complete membership list is included in **Appendix A**.

IHEA holds a unique position in HE as a representative peak body of independent HE providers. Membership in IHEA is only open to providers registered with the Australian regulator – Tertiary Education Quality and Standards Agency (TEQSA). However, a significant proportion (40%) of IHEA members are dual and multi-sector providers who also deliver Vocational Education and Training (VET), English Language Intensive Courses for Overseas Students (ELICOS) and sometimes, High School programs.

## **Position**

In principle, IHEA supports the Bill, as it puts students first, consistent with IHEA's ongoing advocacy for a more equitable tertiary student loan scheme. However, IHEA highlights this Bill amends minimum loan repayment thresholds without implementing equitable tertiary student funding settings for all Australian students. The Bill proposes to remove indexation and raise minimum repayment thresholds (to the median wage), which is a good outcome for students given current pressing economic conditions. While the Bill before the Senate Education and Employment Committee (the Committee) is contextually positive for students, further amendment is required to ensure all tertiary students are treated fairly and equitably under Government funding arrangements.

Students who study at an Independent higher education provider are still required to pay a 20% loan administration fee (tax) above and beyond their student debt loan amount. The following figure exemplifies the additional cost to students who choose a quality non-university provider to complete their studies.

IHEA calls for equitable loan fee settings for all tertiary students. Current student loan funding arrangements continue to distort student choice in favour of providers and courses that may not necessarily be best suited to students' interests nor their long-term career success. The loan tax commences as an additional 20% charge on the principal loan amount and continues to grow through the compounding impacts of indexation. This Bill will potentially help many students struggling to live and pay their loans based on the current minimum repayment threshold. However, existing inequitable arrangements still entrench disadvantage and longer-term debt for students in Australia's Independent higher education sector. IHEA advocates to end student loan inequity by ending the loan tax, which iniquitously only applies to independent sector students.

Concerning the removal of loan indexation, from a Federal Budget perspective rising inflation levels make an argument for retaining indexation on loans. However, from a social equity perspective and putting students' first, removal of indexation would increase access to higher education as indexation substantially increases student loan debt (consider here the impact of the 20% loan tax). Further, if students take a long time to pay their debt or reach the minimum repayment threshold, their loans will continue growing - impacting their life-long learning and in the first instance, study choice. Consequently, IHEA advocates for the development of a universal, income-contingent loan scheme with equitable loan settings for all tertiary students. Ideally, such a scheme would include loan parameters that encourage early and timely repayment to mitigate against longer debt repayments given associated impacts on debt on financial independence.

On behalf of IHEA, its members, and the students they serve, thank you for this necessary step towards student-equity policy and for considering the matters raised in this submission.
