This paper covers the key areas of interest to the Committee, including innovation, interactions with the private sector and outcomes for women and girls.

Outcomes for women and girls is central to this paper and there is a section on Gender Equality with a focus on integrating gender analysis, new programming approaches and gender equality performance.

Regarding innovation, Oxfam Australia won the 2017 Australian Financial Review 'Best Social Innovation' for our Weather Index Insurance program and pages 38-39 of the *Future of Australian Aid* outlines more information on innovationXchange and gives recommendations in this area.

Considerations of the private sector are integrated throughout our paper as an integral part of the future of aid, both with regards to innovation as well as being relevant to accountability and safeguards in the delivery of aid. The paper also mentions the crucial role the private sector plays in ensuring human rights are upheld across their operations.
