**Senator Janet Rice asked:**

**Senator RICE:** Okay. I want to talk about the funding for the Tully Multi-Use Sporting Complex and Grandstand Project because that does seem to be an instance of that. It's funded through the Community Development Grants program, isn't it?

**Dr Bacon:** Because we've got over 1,400 projects in the CDG program, we don't carry with us lists of every project that we have. Sorry, we're going to have to go back through our records, take that on notice and find out information for you on that specific project. We don't have the details of that one particular project here with us today.

**Senator RICE:** My understanding is that it was announced on 24 April and that we've got correspondence from the ANAO indicating that the Prime Minister's office shifted a \$3 million project in the Kennedy electorate out of the community sports infrastructure program on the basis it was being funded from another program, so I want to know whether that was the same project. Was it this project?

**Dr Bacon:** I'm sorry but we don't have the details in front of us. As I said, there are over 1,400 different projects in this particular program. I'm afraid we will have to take that on notice and search through our records to get you that information.

**Answer:**

The Tully Multi-Use Sporting Complex project is funded through the Community Development Grants (CDG) Programme.

The \$3 million funding for the Tully Multi-Use Sporting Complex project was included in CDG as part of the 2019-20 Budget process.

**Dr Bacon:** We will just double check that. It's not something we focused on in preparation for today. We will just double check and make sure that that's correct.

The Department of Infrastructure, Transport, Regional Development and Communications is not aware of any projects from the community sports initiative that have been moved from the Department of Health to the Community Development Grants Programme, managed by the Department of Infrastructure, Transport, Regional Development and Communications.

**Senator Eric Abetz asked:**

**Senator ABETZ:** The programs to which we've just referred, between 2007 and 2013, how do they, if they do, differ to the current operation of these programs?

**Dr Bacon:** We don't have examples of the program guidelines for that previous program. I do have in front of me a copy of the ANAO's audit of that program, but we're less familiar with that program because it's not the one that we currently administer. But we'd be happy to take on notice any details about the program guidelines or how it was administered, if that would be helpful?

**Senator ABETZ:** If you could—if it doesn't occasion too much work for officials.

**Answer:**

The Community Development Grants Programme (CDG) (2013–2026) and the Better Regions Program (BRP) (2007–2013) were established by incoming Australian Governments to fund election commitments.

CDG and BRP were both subject to performance audits by the Australian National Audit Office (ANAO) and the audits acknowledged that each program was effectively designed and administered to deliver the government's election commitments.

The table in **Attachment A** provides a comparison of the purpose for CDG (2013–2026) and its predecessor BRP (2007–2013) summarised by the ANAO.

<b>Purpose</b>	The Community Development Grants Programme (CDG) originated from commitments made by the then Opposition in the lead-up to the 2013 Federal election. Its coverage has been extended over time so that it now includes commitments from the 2016 election as well as uncontracted projects from programs that were abolished following the 2013 election and other commitments.	The Better Regions Program (BRP) was announced by the then opposition during the 2007 Federal election campaign as a vehicle for funding various election commitments. The commitments allocated to the Better Regions Program related to projects such as the revitalisation of main streets in towns, construction of multi-purpose community and resource centres, major sport and recreational venues and community transport infrastructure.

**Senator Eric Abetz asked:**

**Senator ABETZ:** Alright. That is understood. With the 124 projects that were shifted from ITRD&C—from you guys—through to Health, was that the totality of the projects? None were left behind?

Dr Bacon: They were all the projects, as I think Ms Purvis-Smith outlined, that were valued at \$2 million or less, that related to—

**Senator ABETZ:** Sorry, I should have clarified that, yes. In that category, none below the \$2 million threshold were left behind to be administered or run by your department? Is that correct?

Ms Purvis-Smith: Sorry, we're just making sure that we've got the right answer for you.

**Senator ABETZ:** Look, take it on notice.

**Ms Purvis-Smith:** We can take that on notice to make sure that we give you the correct answer. We're aware that there were 124 which, at the time, we believe was the totality, and we will check whether there are any further in relation to time periods as well.

**Senator ABETZ:** Alright, thank you very much.

**Answer:**

The Department of Infrastructure, Transport, Regional Development and Communications can confirm that the Female Facilities and Water Safety Stream was transferred to the Department of Health on 21 August 2019. A list of these projects was tabled at the hearing.

The Department has identified three (3) Community Development Grants projects valued at under \$2 million that appear to be sport related that remain in the Community Development Grants programme. A list of these is provided at [Attachment A](#).

This will include replacing the existing asphalt playing surface with 19mm synthetic grass surface, replace existing mesh fencing, remove blockages and upgrade draining soaker pits.

**Dr Bacon:** We were actually trying to look up this morning and yesterday to see if we can get more precise information about when project announcements were made I think, as Ms Purvis-Smith has outlined when the decision was made to fund the program, which was in the budget papers for our portfolio, there were no projects announced at the same time that the program itself was announced, as far as we can see. So we would just have to double-check when the actual projects were announced and the timing of that. Given that the Department of Health administers that program and all the projects under it, they would have that detail, but we just haven't been able to lay our hands on it quickly.

**Senator Nita Green asked:**

**Senator GREEN:** I apologise in advance, as I did miss the start of your evidence, so if I am going over things for the second time, I will try to be as brief as possible. First, in preparing the audit, the ANAO referred to sources of evidence including email records held by both the Department of Health and the department of infrastructure, including advisers from the minister's office involved in deciding the projects. I'm just going to go through a list of those documents, because I want to know whether you have copies of those documents. If you do have copies, can you take on notice to table those? The first set of documents I am interested in is the details of all the applications made under the Community Sports Infrastructure Program, and a summary of the applicants if that's available?

**Dr Bacon:** We're very happy to take that on notice and double check that. I'm not aware that we do, but I would like to double check that on notice, if that's okay.

**Answer:**

The Department of Infrastructure, Transport, Regional Development and Communications did not administer the Community Sports Infrastructure Program and does not have records relating to the administration of this program.

**Senator Nita Green asked:**

**Senator GREEN:** I'll move on to another issue. We do know that, through responses that have been given to this committee—and I'm sorry; it was a little while ago now because of the break that we've taken—there was an individual from within the Prime Minister's office who was referred to as a senior adviser, infrastructure, transport, regional development, cities and sport. We understand that the Minister for Sport's office used an email account provided by your department. So can I just double-check: did an adviser within the PMO use an email account provided by your department for communications in relation to the program?

**Dr Bacon:** I don't think so. From a corporate services perspective, the way that ministerial offices are usually supported is: relevant portfolio departments will provide administrative back-office type support to ministers' offices. Currently we have nine ministers in our portfolio. Some of those ministers are cross-sworn to other portfolios. There would be a variety of different arrangements within our portfolio as to which department provides their back-office email systems. We at no point would've provided those back-office systems for the Prime Minister's office.

**Senator GREEN:** Can you just double-check that though? Can you take that on notice? I think there has been some evidence about that email account being provided by your department. If you can just double-check, that would be helpful.

**Dr Bacon:** If it were an email account held by someone in the Prime Minister's office, we would not have provided it. If it were about the former sports minister's emails, my recollection is that that back-office support was provided by the Department of Health, but we can check that point for you.

**Senator GREEN:** Thank you. And if there are emails related to that account, I just want to check who those emails came from, but we can put that question on notice to you.

**Answer:**

Neither the then Department of Infrastructure, Regional Development and Cities nor the then Department of Infrastructure, Transport, Cities and Regional Development provided email accounts for staff of the Minister for Sport.
