## Murdoch Media Inquiry Bill 2023 Submission 10

As a parent, I am concerned about democracy as a whole, as lies are echoed by the media and lead to deny/doubt/delay urgent action needed. Everyone will agree Australia doesn't need a Jan 6 incident in Australia where tens of thousands of people stormed the US congress to stop the peaceful transition after the election. It happened mainly because trusted neutral media, acceptable to most, no longer exist in the US. Slowly such a trend is happening in Australia especially after Murdoch media concentration.

Rolling Average time over 12 months for ACMA investigation is a good nine months.
- 3) While Murdoch Fox news pre-settled defamation cases before trial in US & Australia and few anchors fired, it was after Jan 6 and opened a can of worms of how TV executives & anchors were ready to lie for viewership even if they themselves don't believe it . So, we need a Royal commission to bring out how their fake & hate news has impacted people, Government and meaningful actions.
- 4) A lot of public interest news & corruption have been bought out by individual social media rather than major media. Whether it was #Barilaro #JobForMates or #RoyalCommissionForRoboDebt or #Big4Consultants, concentrated media is suppressing these. Likewise, a useless word by politicians is made viral while their policies are not.
