

SUBMISSION to Senate Education & Employment Legislation Committee.

Reference: COVID-19 Vaccination Status (Prevention of Discrimination) Bill 2022 and the Fair Work Amendment (Prohibiting COVID-19 Vaccine Discrimination) Bill 2023.

Summary:

1-0. The Amendment should fail since it is, in itself, discriminatory, giving favourable bias (by exception) to a drug which does not qualify as a “vaccine” (judging by its performance) and which recent data evidence show has adverse effects ranging from mild to fatal.

2-0. There is no place in Australia for discrimination, whether by race, colour of skin, sexual preference, disability, age, *or medical status* (including “Covid-19 Vaccination Status”). The original Bill as proposed seeks to uphold and protect this policy. The Amendment should fail.

3-0. Australia is a signatory to seven major International Human Rights agreements, including the International Covenant on Civil and Political Rights, which gives (inter alia) each person the right to autonomy over his or her own body, and the right to reject participation in any medical experimentation, without coercion.

This did not happen: the “vaccine” uses experimental DNA technology which was not fully explained to recipients, nor were any possible risks; people were told “No jab, no job”—this was coercion, denying free choice; and doctors were told they would lose their practising certificates if they did not comply with promotion of the “vaccine”, under national health guidelines. Therefore, there was no proper “informed consent” given prior to injection.

4-0. The COVID-19 mRNA genetic modification injection/ “vaccine” did not receive full, long-term safety studies prior to rollout; nor did Pfizer, Moderna and other drug manufacturers receive full approval from the Australian Therapeutic Goods Administration for this type of injection. The COVID-19 so-called “vaccine” was rushed to the market at “warp speed” (as opposed to years of safety trial testing) by drug manufacturers under the apparency of a “deadly” pandemic. It is now apparent the effects of this drug (“vaccine”) are worse than the pandemic virus itself: **In 2022, Australia recorded the highest ever excess mortality rate since 1919** (22,886 deaths, or an increase of more than 15% over historical average). This is a national disaster! Like a Qantas A380 airbus crashing every week!

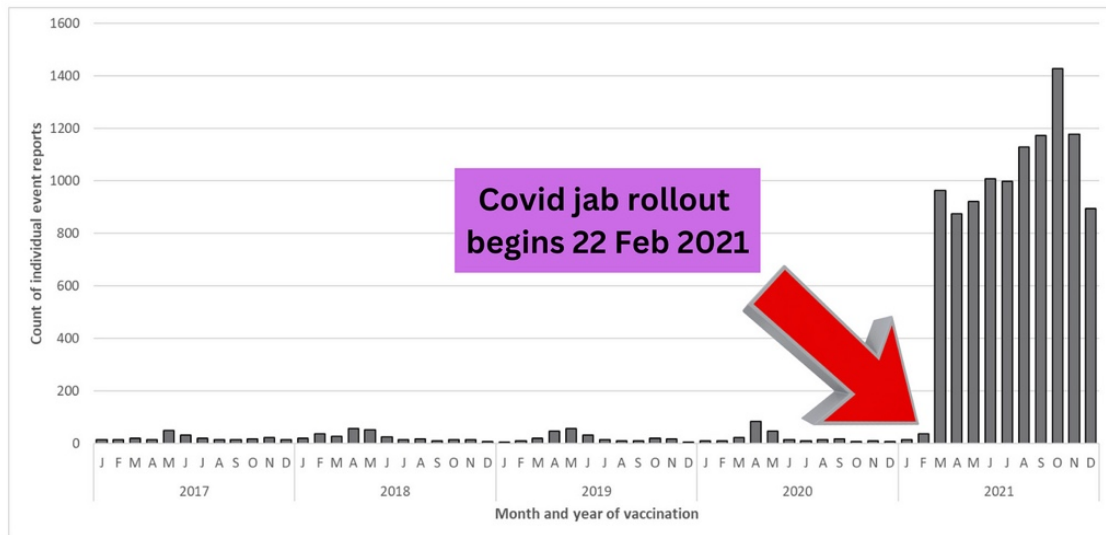


Figure 2: Adverse events following immunisation reported to WAVSS by month, 2017-2021, excluding active surveillance reports for routine vaccination adverse events.

In 2021, adverse events following immunisation (AEFIs) with the Covid vaccines were reported at almost 24x the rate (per 100, 000 doses) of AEFIs for all other vaccines combined.
