Please forgive us for late submission of these documents (attached) aimed at helping the inquiry. The main author/mentor of the documents is Civil Liberties Australia member, Felicity Gerry QC, an acknowledged world authority on legal matters in relations to human trafficking. She has been busy in London on a seminal case*, which has delayed compiling this material.

CLA believes the three main efforts Australia should make at this time are to:

- 1. Enact laws that create mandatory protection for victims of human trafficking;
- 2. Enact criminal laws providing a complete defence to any criminal charge when committed by a victim of human trafficking and because they were victimised within the meaning of the Trafficking protocol; and
- 3. Enact corporate reporting mechanisms in relation to slavery, forced labour and human trafficking, with an annual report to parliament.

Other suggestions for further changes are in the attachments provided.

Thank you for the opportunity to make a submission. Lead author for this submission is Felicity Gerry QC, co-authors are Narelle Sherwill and Bill Rowlings.
