#### Senate Select Committee on Work and Care

### Call for submissions

Issue date: 10 August 2022

A Senate [Select Committee on Work and Care](#) has been established to inquire into the impact that combining work and care responsibilities has on the wellbeing of workers, carers, and those they care for.

The Chair of the Select Committee, Senator Barbara Pocock noted that most Australians will have care responsibilities at some time over their working lives – whether caring for aged parents, friends or family with disabilities, or as parents. She said that the purpose of the committee is to investigate ways in which jobs and care responsibilities can be combined to create better outcomes.

### Call for submissions

The committee is seeking submissions from a wide range of people and organisations, including individuals with work and care responsibilities.

Committee Chair, Senator Pocock indicated that the committee wants to hear from people in different kinds of jobs, people with different kinds of caring responsibilities, people in cities, regional and rural locations and from First Nations communities.

“It is important that we hear from young people, people with disabilities, older people and those involved in caring for them along with workplaces, workers, managers, and researchers as well as employers, unions and professional associations,” she said.

Submissions are sought by **8 September 2022**.
