Thank you for the opportunity to make this submission on behalf of the Liberal Party of Australia.

## Introduction

The Federal Secretariat is the coordinating body for submissions relating to Commonwealth electoral laws and the Australian Electoral Commission (AEC) usually through the Joint Standing Committee on Electoral Matters (JSCEM) of the Commonwealth Parliament.

There has only been very limited time to prepare this submission and to consult stakeholders as extensively as would be usual with a JSCEM process.

## Terms of reference

The terms of reference of this inquiry are set out below:

“Commonwealth legislative provisions relating to oversight of associated entities of political parties, with particular reference to the adequacy of:

- (a) The funding and disclosure regime relating to annual returns;
- (b) The powers of the Australian Electoral Commission with respect to supervision of the conduct of, and reporting by, associated entities of political parties; and
- (c) Any related matters; and

That the Senate direct Senator Sinodinos to appear before the committee to answer questions.”

## **AEC**

To assist the Committee I would make the following points.

Firstly, the Federal Secretariat has a good working relationship with the AEC.

We respond promptly to any AEC inquiry and have no outstanding matters in dispute with the AEC at present.

While issues can and do arise from time to time, as a general observation, we believe that the AEC is a highly competent and professional organisation and in particular that it conducts its funding and disclosure obligations fairly and efficiently.

Where there are any points of clarification or additional information required by the AEC we work constructively with them to resolve such matters according to law.

### **Funding and Disclosure**

Secondly, in our view the current arrangements set out in the Electoral Act for the funding and disclosure regime in general and for annual returns by parties and other entities in particular works adequately.

Before any significant change were to be contemplated we believe there would have to be a strong case and a thorough review by the established Parliamentary body, the JSCEM.

One area of modest but sensible reform for instance would be to have greater clarity in the form information is being disclosed. At present the categories (a) donations or (b) other income can be confusing as “other income” picks up numerous different categories which might be more accurately characterised.

### **Associated Entities**

There are 192 “associated entities” for political parties of all kinds listed on the AEC website for the 2014-15 year.

A copy of that list is attached.

“An associated entity” is defined by section 287 of the *Commonwealth Electoral Act 1918* as an entity:

- that is controlled by one or more registered political parties; or
- that operates wholly, or to a significant extent, for the benefit of one or more registered political parties; or
- that is a financial member of a registered political party; or
- on whose behalf another person is a financial member or a registered political party; or
- that has voting rights in a registered political party; or
- on whose behalf another person has voting rights in a registered political party.

Given the definition a wide range of bodies are declared by the AEC as “associated entities”.

Each has its own structure and varying degrees of complexity in its governing framework. Its officers may include staff depending on the nature of the body concerned.

Some associated entities are essentially investment structures holding property shares and cash and are either closely associated with or essentially “owned” by a political party or parties for instance through appointment of their management body by the state or federal executive of a party.

Others are more independent and some are completely independent in their management and decision making albeit directing funds to one side or another of Australian politics consistent with a broad philosophy.

Some receive donations; others essentially manage a corpus of existing assets paying part of the proceeds in support of organisations they wish to assist.

Some have small boards of management and membership; others have elaborate internal structures and much larger memberships arising from a wider role in the community such as a union.

Some associated entities support a variety of parties and may change their pattern of financial assistance over time. Some largely support only political parties; others also contribute funds to non party bodies such as think tanks and independent public policy bodies unaffiliated with political parties.

Some are administered professionally by paid staff or directors and have access to sophisticated legal and accounting advice to meet their compliance obligations and others are essentially volunteer bodies who undertake their compliance obligations without recourse to professional advice.

Some of these bodies have considerable financial resources. They receive and disperse reasonably substantial sums of money and others have only relatively small sums of money either in their asset base or in the capacity to make specific payments to political parties.

As a general observation we believe that the current regime is adequate and carries out the obligations set out in the Commonwealth Electoral Act.

Subject to compliance, we also believe in encouraging engagement with the democratic political system by a wide cross section of our society.

Our capacity to make detailed recommendations on such short notice covering such a diverse group of entities is obviously limited.

In the first instance the AEC will be able to advise the Committee if it has any particular compliance difficulties with the "associated entities" they supervise.

As noted earlier the Federal Secretariat of the Liberal Party of Australia works constructively with the AEC to ensure we comply with the law and assist the AEC in the conduct of its duties.

If there are particular matters within the jurisdiction of this Parliament that I can assist with please do not hesitate to identify them and I will seek to assist the Committee if possible.
