Re: Senate Economics Legislation Committee, and

Re: Inquiry into the Australian Charities and Not-for-profits Commission (Repeal)

(No. 1) Bill 2014 (Bill)

I refer to the attached Answer to Estimates Question 334, from the 2013-14 Additional Estimates Hearings (ref Hansard Page: 27/02/2014 CA104/CA105) (the **Answer**).

That Answer was recently brought to my attention, and that of my colleague (and the principal of our firm) at Prolegis Lawyers*, Anne Robinson.

You will see that both Anne and I are listed on page 2 of the Answer as persons (representing the Charity Law Association) who had been spoken to by the Department of Social Services (DSS) in relation to the proposed Civil Society National Centre of Excellence (the Centre).

I am writing on behalf of both myself and Anne Robinson;

- To correct the record (see the next paragraph below), and
- To request that our names be deleted from the list provided by DSS in response to Question on Notice 334.

OR

Alternatively, if it is not possible to delete our names from that list, to request that it be noted
that, in both our views, the information provided by DSS to the Parliament was incorrect and
potentially materially misleading.

Specifically:

- Our only relevant contact with DSS officers was at a Not-for-Profit Forum at the University of Melbourne Law School on 28 February 2014 (the Forum).
- Three DSS officers and an adviser to Minister the Hon Kevin Andrews were present at the Forum. But they deliberately and expressly did not participate in any way in any discussion at the Forum, and the Ministerial adviser expressly disavowed any intention on the part of him and the DSS officers to engage in any form of consultation at the Forum.
- As best we can recall, none of the DSS officers present, nor the Ministerial adviser, asked any
 question of either of us.
- In our view, it is quite incorrect, and potentially materially misleading, to suggest that their or our
 presence at the Forum involved our being spoken to, or in any other way consulted, about the
 proposed Centre, the above Bill, or the proposed abolition of the Australian Charities and Notfor-profits Commission.
