Table 2: For all communities the percentage of clients by gender who were placed on conditional income management for each financial year 2008 to 2018.

As at 18 March 2019 out of the 880 clients who have been placed on Conditional Income Management since the commencement of the FRC, 43.4% are males and 56.6% are females.

As at 18 March 2019 out of the 124 clients currently on Conditional Income Management, 21 (16.9%) are males and 103(83.1%) are females.

As at 18 March 2019 out of the 103 female clients currently on Conditional Income Management, 72 (69.9%) female clients were put on Conditional Income Management solely as a result of School Attendance notices. Please note a client may be placed on Conditional Income Management as a result of more than one type of notice at any given time.

In jurisdiction School Attendance notices account for nearly two thirds of the notices received by the Commission with Magistrates Court Notices accounting for just over a quarter of the notices. Since the commencement of the Commission females account for more than 50% of Housing Tenancy and Child Safety and Welfare notices, and over 70% of the School Attendance and School Enrolment notices. Court matters relating to the District Court, Magistrates Court, Domestic Violence Breach and Domestic Violence Orders have a greater proportion of males. Primarily Conditional Income Management Orders are issued to stabilise a client's circumstances, particularly where children or other vulnerable people are concerned.

Please note Doomadgee only receives School Attendance, School Enrolment and Child Safety and Welfare notices and came under the jurisdiction of the Commission on 7 August 2014/the District Court trigger was introduced on 28 November 2014/and the Domestic Violence triggers were introduced on 17 December 2015.
