## Question

Are there some lessons in things you have observed that we could share and have a look at, ways perhaps as Parliament we can, and not just on that one issue, but more generally assist Australians with how they volunteer and donate and support programs overseas?

## **Answer**

The Department of Foreign Affairs and Trade (DFAT) provides information to support responsible volunteering.

DFAT engages in quarterly intergovernmental meetings with the International Forum for Volunteering in Development, a global network of non-government and state organisations that work with volunteers. The Forum shares information, develops good practice and enhances cooperation across the volunteering in development sector, including through convening research and developing standards.

DFAT raises awareness around responsible and child safe volunteering through the Australian Government's international volunteering program, the Australian Volunteers Program.
