REQUIREMENTS AND AUSTRALIAN DEFENCE FORCE AIR TRAFFIC
CONTROL COMPLEX INFRASTRUCTURE PROJECT

This letter is to inform the Parliamentary Standing Committee on Public Works (PWC) of the nature and extent of community consultation undertaken as part of the AIR5431 Phase 2 and 3 Defence Air Traffic Management and Control System Facilities Requirements and Australian Defence Force Air Traffic Control Complex Infrastructure Project (the Project).

Broadly, the strategy for community consultation adopted by Defence was undertaken with the following objectives:

- ensuring that the public was informed about the Project using cost effective, wide ranging communication channels; and
- ensuring the public had every opportunity to raise issues of concern or seek further information.

The consultation activities undertaken included:

- Detailed email correspondence with local groups, State and Federal members, with individual briefings conducted where requested. The members and groups consulted, with a short description of the outcomes of the contact are detailed in Annex A. An example of the correspondence sent to the respective groups is detailed at Annex B;
- Advertisements in the local newspapers, listed in Annex C; and
- A series of Public Consultation Sessions undertaken, details listed at Annex D;

Key issues raised by the Community through the Consultation sessions are listed at Annex E.

In conclusion, no significant issues have been identified during Defence's community consultations that will impact on the proposed works, and Defence is satisfied that it has taken all reasonable steps to inform the Community about the Project and to provide opportunities for the Community to raise concerns.

An example of the letter issued to stakeholders is as follows:

I am writing to you on behalf of The Department of Defence regarding RAAF Base Richmond and the AIR5431 Phase 2 and 3 Defence Air Traffic Management and Control System Facilities Requirements and Australian Defence Force Air Traffic Control Complex Infrastructure Project.

In line with the direction of the National Aviation Policy White Paper, Defence and Airservices will harmonise the military and civil elements of the National Air Traffic Management system as part of a joint project referred to as the Civil and Military air traffic system and branded as 'OneSKY Australia'. This project aligns with the Coalition's *Policy for Aviation*, August 2013, and the guidance from the Australian Civil-Military Air Traffic Management Committee.

The project will deliver new and upgraded facilities to support the ongoing provision of air traffic services within Defence controlled airspace and to support the Defence components of the Onesky Australia Program.
