### RE – THE MARRIAGE AMENDMENT BILL

The Family Council of Victoria has grave concerns that Ministers of Religion, Marriage Celebrants and Religious organizations will be the targets of vilification and subsequent legal action due to further amendments in support of same-sex marriage once the process has begun. Precedents have been made in other countries where same-sex marriage has been legalised and the previous guarantees of protection for religious ministers and organizations were challenged and amended to exclude any exemptions whatsoever.

Due to what has happened in other jurisdictions, there is little doubt that people of conscience or religious conviction will loose their freedoms and be forced to celebrate an activity that causes them anguish and psychological pain. In some cases, individual businesses have been bankrupted by such laws and the owners jailed for failing to support same-sex marriage. The Australian Government must not create laws that *contradict freedom of conscience and personal liberty*. Any attempt to create a law that limits guaranteed (as specified in the Australian Constitution) personal freedoms would be detrimental to the public and especially to anyone in the marriage/wedding industry.

The Family Council of Victoria recommends that the Select Committee rejects the Bill as it will conflict with personal liberty and freedom of conscience – a right which is guaranteed under our Constitution and International Law.
