Some important points, which are very well developed facts as well:

- Mothers and children are more at risk of abuse, harm and even killing.
- Child sex abuse, other sexual abuse, domestic violence is on rise.

- Mother and children are weak, emotional and sensitive, biologically and psychologically.
- Mothers go through monthly bleeding, with pain and mood swing which goes along with it. By nature and in order to carry a child. That is how we are here and human civilisation continuous.
- Happily she bears the nine months hardship for carrying a child, nine months restless nights, vomiting, hard to mobilise and taking all sorts of care along with her daily work and maybe caring for other children, husband and work for bills as well.
- After divorce fathers are making all the efforts to hide their income and dump their responsibility on **Centrelink** and **Department of Housing**. It is a fact that fathers owe millions of dollars to Child Support Agency.
- Mother are doing both the job as a father and as a mother (in our client's case after separation ex husband immediately moved with new girl friend, didn't paid any child support for years, mother was running with her three children to the department of housing while father was having holidays in Fiji with his new girl friend and after his holiday ex husband starts court process and drags mother to court for children's overnight stay during weekend. What kind of responsibility is that? And court gave him whatever he wanted and mother kept doing his duties as well to find a house and also pay all the bills and also attending to children's day to day needs.)
- **Frustrated mothers with No HELP and NO HOPE, from the Family court and fathers, are running away with their children far away from the tensions and in search for peace.**



Kindly note that, HAGUE CONVENTION's aim is ultimately to protect a child, and only mothers are designed and programmed to do that, with her only motive to raise this child with care and comfort. And that is her commitment to herself.

She is programmed, to protect her child from any harm whether it is common cold or any physical or even emotional harm, which can hinder child's best development. Even in animals, mother starts preparing for her babies before hand and nurtures them, feeds them with so much of efforts. Even in animals, mother will never allow anybody to harm her child if she detects the threat.

We observe animal behaviour, we do research on them for years and we appreciate and understand animals but when it comes to human mother we don't understand her, we call her criminal.

In animals, mother protects her territory but in human case her territory (her dreams) gets badly destroyed by her own husband or partner and he does it without considering children's well being and its long term effects on their lives. That is when mother thinks and takes action to take her child away from harmful circumstances, instead of running to court for many years and, ultimately end up with mental and physical exertions and end up with her badly lost and disturbed child.

Conclusion and Recommendations:

1. Mothers taking their children or child overseas should never be considered as a criminal activity, where mother is taking her own child. Her inner nature says her to protect, care and nurture her child peacefully. Instead reform your Family Law "FLAWS" and

2. After separation or divorce, mothers with children or a child should be immediately supported and assisted for accommodation and other needs by the father or by authorities if needed. 

Fifteen million youth - all products of dysfunctional families. Every year 3.4 million kids try drugs, and half a million attempt suicide in the United States. In 1994, 1.2 million divorces took place in the U.S. and experts predict that half of all new marriages would end in divorce.

Thirty-eight percent of children now live without a biological father. 6.6 million children live with divorced single parents, mostly mothers whose ex-husbands tend to fade away from their children. Twenty percent of children in the United States ages 6-12 have not had a 10-minute conversation with a parent in a month. Their conversation is with TV, which acts as their mother, father, baby-sitter, and teacher. By the time they are teenagers, children have seen an estimated 18,000 violent murders on TV. This is family life in USA. "Something is wrong with the entire American family," writes Martin Marry, professor at the University of Chicago in the Los Angles Times. "*One has the weird sense that America is a country with many children but without adults.*"
