Refer page 21 of the Australian Antarctic Science Council's April 2023 report on its review of the Australian Antarctic Science Funding Model provided in response to IQ23-000279.

In January 2023, Daryl Quinlivan AO completed a Functional Alignment Review of the Department of Climate Change, Energy, the Environment and Water. The review noted that although some Australian Antarctic Division (AAD) staff considered the AAD should be a separate agency, there was general agreement that the AAD should be more closely integrated with the department. These findings were accepted by the department and the department's corporate services have lent in heavily to support AAD.

# Senator Bilyk asked:

Senator BILYK: One of the questions I asked was how much money was spent on consultants for the following financial years, and I went back to 2019-2020. In 2020-2021, the answer you've given me is \$20,622,637. Is that a typo or is that correct?

Ms Campbell: I asked that question as well; my understanding is that it's correct. Senator BILYK: Twenty million dollars on consultants? I understand you weren't in the position then, Ms Campbell, but can I get a breakdown of who the consultants were, the individual costs attributed to them and for what reasons they were needed?

Ms Campbell: Yes, we can take that on notice.

#### Answer:

The Australian Antarctic Division spent \$20,622,637 on consultancies in 2020-21. The majority of this spend related to approved critical project work of which additional funding was received. A detailed breakdown of the spend is provided at **Attachment A**.

CHAIR: Has anyone left? Are you aware of anyone leaving the Science Branch? Any scientists leaving? Surely you must be aware if scientists are leaving because you're the senior person in the Science Branch, Professor Webster.

Prof. Webster: I'm not aware of any scientists that have left in the past month, since we held the inquiry.

CHAIR: What about the past two months?

Ms Campbell: The time frames are hard to keep track of. I can certainly think of a couple of scientists that have left in the last four months, but we'll certainly—

CHAIR: But none since our last hearing? Prof. Webster: Not that I'm aware of.

Senator BILYK: What about other staff, not just scientists?

Ms Campbell: Again, we'll take that on notice.

Senator BILYK: I'm happy for you to take it on notice.
