## COMMUNITY CONSULTATION REPORT FACILITIES TO SUPPORT ADVANCED GROWLER PHASE 6

- 1. The Facilities to Support Advanced Growler Phase 6 Project was referred to the Parliamentary Standing Committee on Public Works on 7 February 2024. The project proposes to deliver facilities and infrastructure at:
- a. RAAF Base Amberley in the Ipswich Region, Queensland; and
- b. Delamere Air Weapons Range in the Victoria Daly Region, Northern Territory.
- 2. This letter is to inform the Committee of the nature and extent of community consultation that has been undertaken by the Department of Defence for these proposed works. The aim of the consultation is to ensure local communities and other stakeholders are:
- a. well informed about project details through effective and proven communication channels; and
- b. provided the opportunity to raise any concerns or issues, or to seek further information so that, wherever feasible, Defence could address these in its proposed works.
- 3. The following stakeholder and community consultation activities were delivered in accordance with the project's comprehensive community engagement strategy:
- a. Community information sessions were advertised in relevant local newspapers in the Ipswich and Katherine regions. A project mailbox was also established to receive submissions and questions about the project. These details are included in the advertisements shown at **Annex A**.
- b. Three community information sessions were conducted, including one drop-in session each in Katherine and Ipswich on 5 March 2024 and 14 March 2024 respectively, and an online virtual session on 18 March 2024. Information presented by Defence to the public is outlined at **Annex B**, and level of attendance is provided at **Annex C**.
- c. Key stakeholders, including Federal, State and Local Members of Government, and local community members were offered a personal briefing about the project. An example of the invitation that was sent out is at **Annex D**. A list of all stakeholders

engaged by the project, including the status of each engagement, is provided at **Annex E**.

- 4. Information about the proposed works was generally well received at the community information sessions and feedback to date has been positive. Defence has not been made aware of any objections to the proposed works.
- 5. Comments raised by members of the community focused on:
- a. highlighting the limited availability of accommodation, housing and support services in the Katherine and Victoria Daly regions for those construction personnel who do not reside locally;
- b. maximising opportunities for local industry participation for proposed works at the Delamere Air Weapons Range, noting the current constraints in the Katherine and Victoria Daly regions;
- c. limiting further impact to the already damaged access road from Victoria Highway Turn-off (owned by the Northern Territory Government) into the Delamere Air Weapons Range;
- d. avoiding further environmental impacts from use of the Delamere Air Weapons Range;
- e. understanding if there would be any increase to Communication Tower capacity at the Delamere Air Weapons Range;
- f. understanding how Defence designs and maintains wash bays in the Northern Territory;
- g. identifying and minimising noise and traffic impacts to local neighbouring residents at RAAF Base Amberley; and
- h. understanding potential impacts to existing fence lines at both RAAF Base Amberley and the Delamare Air Weapons Range.
- 6. A summary of topics raised during community information sessions, along with the Defence responses, is provided at **Annex F.**
- 7. Consultation activities have concluded. Defence will provide a briefing to Federal, State and Local Members of Government contacted during the consultation process should they request one.

# RAAF Base Amberley, Queensland and Delamere, Northern Territory

## **Project Overview**

Defence is planning a new project that will provide fitfor-purpose facilities and infrastructure to enable integration and interoperability of EA-18G Advanced Growler upgrades with the maintenance, storage, logistics and training operations at RAAF Base Amberley and Delamere Air Weapons Range.

Subject to Parliamentary approval, construction is expected to commence in early 2025, with the project expected to be completed by late 2026.

The project will provide the necessary facilities works at RAAF Base Amberley and Delamere to support integration of the Growler upgrades into Air Force's existing infrastructure. The works include:

- maintenance, logistics and storage upgrades at both Bases to enable effective servicing of the new capability; and
- b. training facilities to support enhanced operation of EA-18G Growler capability, including the ability to conduct joint training exercises and integrated training with other capabilities

These works will be delivered across eleven project elements:

- 1. Upgrades to Existing Next Generation Jammer Maintenance Facility.
- New Next Generation Jammer Secure Ready Storage Facility
- 3. New Next Generation Jammer Container and Ground Support Equipment Storage
- 4. New Mission Control Centre
- 5. New Mobile Threat Training Emitter Systems Maintenance Facility
- Modifications to Existing Air Defence Radar System Storage Shelter
- 7. New Vehicle Wash Point
- 8. Upgrades to Existing Maintenance Facility Road Network
- 9. New Overflow Storage
- **10.** Upgrades to Existing Range Operations Centre Communications Building
- **11.** Upgrades to Existing Infrastructure




Figure 3 – New Mobile Threat Training Emitter Systems Maintenance Facility and Modifications to Existing Air Defence Radar System Storage Shelter, Delamere Air Weapons Range, Northern Territory.




Figure 5 - Upgrades to Existing Range Operations Centre Communications Building, Delamere Air Weapons Range, Northern Territory.

## Katherine - Drop in Session:

- Noted that there is very limited availability of accommodation for non-resident construction personnel in the Katherine and Victoria Daly regions. Enquired if there was any assessment undertaken on the availability of accommodation, housing and support services in these regions.
- Enquired about the opportunity for local industry participation for proposed works at Delamere, noting the current construction industry trade and personnel capacity constraints in the Katherine and Victoria Daly regions.

## Ipswich - Drop in Session:

- Enquired about potential noise and/or traffic impacts on local neighbouring residents, particularly on the Cunningham Highway during peak Base entry and exit periods and during proposed works.
- Enquired if there was going to be any change and/or impact to the existing RAAF Base Amberley fence line, as a result of the proposed works.

**C-2** 

- Neighbouring property owners noted that the frequency of engagement from RAAF Base had decreased from quarterly to bi-annually.
- Noted that the Public Works Committee details, posted online, are not accessible to local residents who do not use the internet. Queried if this information can be published in local newspapers.

## Victoria Daly Region – Virtual Drop in Session:

- Expressed concern about risk of construction traffic causing further impacts on the already damaged access road from Victoria Highway turn-off (owned by the NT Government) into the Delamere Air Weapons Range.
- Enquired if there would be any change or impact to the current Delamere Air Weapons Range fence line.
- Noted the environmental impact to land surrounding Victoria Daly region neighbouring properties from ongoing use of the Delamere Air Weapons Range.
- Enquired if there would be any increase or change to Communication Tower capacity at the Delamare Air Weapons Range.
- Enquired about how Defence designs wash bays, noting design should take into account maintenance difficulties faced in the Northern Territory.
