#### Question on Notice submitted by Mr Josh Wilson at JSCOT hearing on 2 August 2021

Mr Josh Wilson: Also, if you could take this on notice, I think it would be worth the committee having some kind of tabled summary of all of the consultations that occurred with respect to RCEP so that we can look at the forms those consultations took, whether they were seminars, direct consultations or roundtables, or whatever they were, and how they occurred over a period of time. Certainly, the evidence from DFAT was that consultations were early but also ongoing. I think it would be useful for us to see exactly what that meant.

Mr Baxter: I was having a bit of trouble hearing you, so I hope I picked up all of your questions. Just to clarify, my understanding is essentially that you are interested in our reaction to evidence provided to the committee that the level of consultation during the course of RCEP negotiations tended to be greater with larger businesses than with smaller businesses and civil society groups. And then you asked us to provide, on notice, a table of consultations that were undertaken during the RCEP negotiations. We can certainly put something together setting out the consultations that we undertook ...

Mr Josh Wilson: But, yes, certainly, if we could get that table on notice—and, in that table, I'd particularly like to know about sessions that were essentially facilitated. The reference here is to some sessions that were facilitated or hosted by corporations or large-business groups, where to some degree they're the ones who are providing facilities and putting out invitations and all of the rest of it, to which DFAT negotiators then come along and make themselves available. It would be really worth us knowing, or seeing at least, a distinction in the table between the things that DFAT itself has organised and the things that DFAT has been prepared to attend at the invitation of a corporate organisation that has otherwise put its resources into facilitating engagement for, presumably, its members.

#### Response

The public consultation and stakeholder engagement process for the Regional Comprehensive Economic Partnership Agreement (RCEP) commenced in 2012.

The Department of Foreign Affairs and Trade (DFAT) consulted widely and often with Australian stakeholders across sectors, states and territories and interest groups, including civil society and trade unions, throughout the RCEP negotiations. A non-exhaustive list of stakeholder consultations undertaken by DFAT in Australia is at Annex I. This list does not include phone or email contact with individual stakeholders on issues of interest to them, which occurred regularly since the launch of the negotiations in 2012.

At each of the RCEP negotiating rounds hosted by Australia, dedicated stakeholder consultation events were held, including the following:

- Brisbane 24 September 2013
- Perth 27 April 2017
- Melbourne 30 June 2019

A list of Australian stakeholders who attended such events are at Annex II.

Australian stakeholders also travelled to stakeholder events to engage with negotiators at negotiating rounds hosted by other countries participating in RCEP negotiations.

Since the commencement of RCEP negotiations in 2012, DFAT has convened a biannual meeting of peak organisations (including civil society representatives) to provide an update on DFAT-led international trade negotiations and an opportunity for peak organisations' representatives to ask questions about, and comment on, the government's trade agenda. A list of organisations invited to attend the biannual meetings is at Annex III.

In addition, throughout the negotiations, DFAT received written submissions on RCEP from organisations listed in Annex IV.

DFAT also consulted with State and Territory Governments throughout the RCEP negotiations.
