Question:

Earlier this year Defence and Naval Group issued a joint statement containing a list of 137 sub-contractors for the Future Submarine program. This list included just six defence equipment suppliers and 28 engineering or technical firms, whilst only about 50 are Australian-owned and operated.

To pick one example from that list – what contribution to Australian defence industry or sovereign capability is being made by the Royal Agricultural & Horticultural Society of South Australia?

a. Could Defence please provide the Committee with a list of only those sub-contractors providing equipment or technical services for the design and build of the Future Submarines?

Answer:

Sovereign industry is a subset of a broader Australian industry capability that extends to a range of Australian businesses and services. These services support the delivery of capability while providing benefits to local economies and growing Australian jobs.

Royal Agricultural & Horticultural Society of Australia Incorporated (Science Alive) is an educational science fair. Naval Group participated in the educational science fair to attract recruitment and facilitate engagement with Australian educational and science institutions.

The 137 listed companies were those that had, at some time since the Commonwealth signed contracts with Naval Group and Lockheed Martin Australia in 2016, provided a service or equipment related to the Future Submarine Program to either prime contractor. Of these 137, 37 sub-contractors provided or will provide equipment or technical services for the design and build of the Future Submarines:
