  - b. how many are judicial Deputy Presidents and how many are non-judicial Deputy Presidents:
  - c. how many have been enrolled as a legal practitioner of the High Court, of another federal court or of the Supreme Court of a State or of the Australian Capital Territory for at least five years and how many have not been;
  - d. how many are also nominated under section 3ZZAF of the Crimes Act; and
  - e. how many are also nominated under section 6DA of the Telecommunications (Interception and Access) Act 1979.
- 2. How many Senior Members are currently nominated to issue warrants? Please provide a breakdown of:
  - a. how many are part-time Senior Members and how many are full-time;
  - b. how many of the full-time Senior Members have been enrolled as a legal practitioner of the High Court, of another federal court or of the Supreme Court of a State or of the Australian Capital Territory for at least five years and how many have not been;
  - c. how many are also nominated under section 3ZZAF of the Crimes Act and
  - d. how many are also nominated under section 6DA of the Telecommunications (Interception and Access) Act 1979.

- 3. How many Members are currently nominated to issue warrants? Please provide a breakdown of:
  - a. how many are part-time Members and how many are full-time; and
  - b. how many are also nominated under section 6DA of the *Telecommunications* (*Interception and Access*) *Act 1979*.

#### The response to the Senator's questions is as follows:

- 1. Eleven Deputy Presidents are currently nominated to issue warrants under section 13 of the *Surveillance Devices Act 2004*.
  - a. Seven of the Deputy Presidents are full-time and four are part-time.
  - b. All of the Deputy Presidents nominated to issue warrants under section 13 of the *Surveillance Devices Act 2004* are non-judicial.
  - c. All of the Deputy Presidents nominated to issue warrants under section 13 of the *Surveillance Devices Act 2004* are enrolled as legal practitioners in the High Court, another federal court or the Supreme Court of a State or the Australian Capital Territory and have been for at least five years.
  - d. Ten of the Deputy Presidents nominated to issue warrants under section 13 of the *Surveillance Devices Act 2004* are also nominated under section 3ZZAF of the *Crimes Act 1914*.
  - e. All of the Deputy Presidents nominated to issue warrants under section 13 of the *Surveillance Devices Act 2004* are also nominated under section 6DA of the *Telecommunications (Interception and Access) Act 1979*.
- 2. Sixteen Senior Members are currently nominated to issue warrants under section 13 of the *Surveillance Devices Act* 2004.
  - a. Ten of the Senior Members are full-time and six are part-time.
  - b. Fifteen of the Senior Members are enrolled as legal practitioners in the High Court, another federal court or the Supreme Court of a State or the Australian Capital Territory and have been for at least five years, one of the Senior Members is not so enrolled.
  - c. Nine of the Senior Members nominated to issue warrants under section 13 of the *Surveillance Devices Act 2004* are also nominated under section 3ZZAF of the *Crimes Act 1914*.
  - d. All of the Senior Members nominated to issue warrants under section 13 of the *Surveillance Devices Act 2004* are also nominated under section 6DA of the *Telecommunications (Interception and Access) Act 1979*.
- 3. Nine Members are currently nominated to issue warrants under section 13 of the *Surveillance Devices Act 2004*.
  - a. Four of the Members are full-time and five are part-time.
  - b. All of the Members nominated to issue warrants under section 13 of the *Surveillance Devices Act 2004* are also nominated under section 6DA of the *Telecommunications (Interception and Access) Act 1979*.

All of the Deputy Presidents nominated under section 6DA of the *Telecommunications (Interception and Access) Act 1979* are enrolled as legal practitioners of the High Court, another federal court or the Supreme Court of a State or the Australian Capital Territory and have been for at least five years.
- d. All of the Deputy Presidents nominated under section 6DA of the *Telecommunications (Interception and Access) Act 1979* are also nominated under section 13 of the *Surveillance Devices Act 2004*.
- e. Ten of the Deputy Presidents nominated under section 6DA of the *Telecommunications (Interception and Access) Act 1979* are also nominated under section 3ZAAF of the *Crimes Act 1914*.

  - c. All of the Senior Members nominated under section 6DA of the *Telecommunications* (*Interception and Access*) *Act 1979* are also nominated under section 13 of the *Surveillance Devices Act 2004*.
  - d. Nine of the Senior Members nominated under section 6DA of the *Telecommunications (Interception and Access) Act 1979* are also nominated under section 3ZZAF of the *Crimes Act 1914*.
- 3. Nine members are currently nominated to issue warrants under section 6DA of the *Telecommunications (Interception and Access) Act 1979*. Four of the members are full-time and five are part-time.
