**Answer:** The Department wrote to all Royal Commission Community Based Support Services in mid-January 2018 to provide advice about the cessation of the Royal Commission Support Services funding program on 30 June 2018. It noted the continued support that services should provide to survivors until this time, and noted the Department would assist with transitioning clients as required, from 1 July 2018 (Letter at **Attachment A**).

The Department also provides advice to Royal Commission Community Based Support Services during regular state-based meetings between providers and their local Grant Agreement Manager.

At the request of some current support services, the Department provided advice on transition pathways for people who will not be eligible for Redress. The Department also noted the many other Commonwealth services available to assist these people (for example, Find & Connect).

This advice was shared with service providers in meetings in early February in Queensland and Victoria.

The Department also reiterated that people who may be engaging with the Redress Scheme should continue to be supported.

The Department held a subsequent teleconference with all Royal Commission Support Services on 22 February 2018 to provide further information and support.

**Question:** How was the decision to exclude those who have been convicted of offences reached? What was the background?

**Answer:** This policy was a decision of Government, made in consultation with state and territory Ministers responsible for redress.
