Further to your recent conversation with ..... (cced), I am happy to provide you with an update on the FTA Portal.

The services expansion of the Portal is largely complete. Further expansions to include goods and services under are the TPP-11, PAFTA, Hong Kong, and IA-CEPA will be concluded as soon as possible after entry into force of these agreements.

The Portal is still being utilised very well. We estimate it has now attracted 220,000 users since its launch, with 2,600 users per week on average. The average weekly use of the Portal continues to increase steadily.

Please see below

- a) How many TradeSmart Advisors exist? How many clients/companies do they service? And what's the breakdown between metro vs regional/rural areas for both # of advisors and # of clients/companies?
  - A) 29 advisers in 28 offices. 7 metro (mainland capital cities and Gold Coast); 21 offices in regional. Number of clients per year around 1,400. Client split: 650 metro; 750 regional**
- b) How many FTA seminars did Austrade run last year (about 150 by memory)? And what's the breakdown between metro vs regional/rural areas?
  - B) 108 to date since the start of the program, with 109 and 110 scheduled for next week, see attached for the breakdown of location, metro vs rural.**
- c) The 120 technical FTA training sessions were over and above the approx. 150 FTA Seminars, right?
  - C) Yes. The technical FTA training sessions (120) are different to the seminars. The FTA training sessions were delivered nationally by member-based business organisations such as chambers of commerce, industry associations, bilateral chambers, peak industry bodies, universities and TAFE colleges, through the FTA Training Provider Grant program, that Austrade administers. Twenty six grants were awarded over a two-year period.**

d) And of the 120 technical FTA sessions, what's the breakdown between metro vs regional/rural areas?

**D) While Austrade administered the grant program, they did not deliver the technical training sessions and do not have a breakdown between metropolitan and regional training delivery.**

Hi Andrew

Please find the data re the Export Market Development grant ( EMDG) 2017-18, 2018-19 funding and forward estimates was/is \$138.9m.

The payout factor in 2017-18 , for those eligible for more than \$40,000 of reimbursement of promotional expenses, was 29 cents in the dollar. So the maximum level of reimbursement payable was \$72,000 rather than \$150,000 as provided for by the EMDG Act.
