Deputy: Senator Anne McEwen***PUBLIC HEARING FOCUSES ON RIGHTS OF AFGHANISTAN WOMEN AND GIRLS**

A colonel who mentors policewomen and a woman who has spent 20 years advancing the rights of women and children are among several experts to give evidence before the parliamentary inquiry into the rights of women and girls in the Indian Ocean and Asia Pacific regions.

The Human Rights Sub-Committee will hold its first public hearing on Tuesday 13 May 2014 to examine the circumstances of women and girls in Afghanistan – a country that has been a significant focus of Australian military, diplomatic and development efforts over the past thirteen and a half years.

The Human Rights Sub-Committee will hear from four witnesses:

- **Ms Zulaikha Rafiq** – With over 20 years of experience working with national and international organisations in Afghanistan as a women's rights activist Ms Rafiq is the Afghan Women's Educational Center (AWEC) director.
- **Colonel Najibullah Samsour** has over 30 years of experience in the Afghan National Police serving in a range of positions. Colonel Samsour has mentored Afghan policewomen and supported their advancement through the Afghan National Police resulting in a large increase in the numbers and seniority of policewomen in the districts under his command.
- **Mr Mohammad Sharif** is the Policy and Advocacy Officer at Oxfam in Afghanistan, managing Oxfam's national advocacy work on the protection and promotion of women rights, particularly in the context of peace processes and the security sector in Afghanistan.
- **Ms Stephanie Cousins** is Oxfam Australia's Humanitarian Advocacy Lead and is responsible for managing Oxfam Australia's policy and advocacy work in relation to Afghanistan.

The public hearing will on **Tuesday, 13 June 2014, from 12.45pm** in Committee Room **1R6**, Parliament House, Canberra.
