### **Senator Canavan to ask the Minister for Health:**

Please provide the data you have that shows the comparison of costs for Calvary Hospital and Canberra Hospital with their peer hospitals.

**Minister Stephen-Smith MLA:** The answer to the Senator's question is as follows:

The data I referred to during the hearing was from the Independent Hospital and Aged Care Pricing Authority and referred to 2019-20 benchmarking data. In 2019-20, when comparing hospitals against their peers the below is available.

- In 2019-20 the portal shows that Canberra Hospital had a cost per National Weighted Activity unit (NWAU) at a cost of \$6,415. Its peers (principal referral hospitals) benchmark at \$6,384, demonstrating a 0.48 per cent above the national benchmark for its peer hospitals.
- In 2019-20 the portal shows that Calvary Public Hospital delivers NWAU at a cost of \$6,287. Its peers (public acute group A hospitals) benchmark at \$5,919, demonstrating a 6.2 per cent above the national benchmark for its peer hospitals.

More recent data was drawn to my attention following the hearing. This was not available at the time of ACT Government decision-making on the acquisition, but shows that:

- In 2020-21, Canberra Hospital had a cost per NWAU of \$6,339, in comparison to its Peer Group (Principal referral) cost per NWAU of \$6,284.
- In 2020-21, Calvary Public Hospital Bruce (CPHB) had a cost per NWAU of \$5,901, in comparison to its peer group (Public acute group A) cost per NWAU of \$5,904.

The differences in average cost per NWAU between Canberra Health Services (CHS) and CPHB were largely driven by mental health NWAU costs, with CHS seeing consumers with substantially higher acuity. For admitted acute care, Calvary's cost per NWAU was \$40 lower than CHS, while its cost for admitted sub-acute and non-acute admissions was \$210 above CHS.
