The Department has previously sought data on the level of imports and found that disaggregated information on glasswool batt imports (the main product installed under the program) is not available. These are classified by both Customs and the Australian Bureau of Statistics in an aggregated form with other glass fibre products. It is not possible to determine which sectors the material could be destined for, nor whether the material was potentially being installed under the Home Insulation Program.
