COSTINGS BASED ON AN ESTIMATE OF \$3.00/HR PER EMPLOYEE

The cost to provide wage increases of \$3.00 per hour for Certificate III qualified staff and proportional wages increase across all classification for all staff in CCB approved Long Day Care service is dependent on:

- the total number of staff employed
- the total hours worked, and
- the distribution of staff across the classification scale.

Figures from the 2010 Early Childhood Education and Care Workforce Census show there were 67,975 educators at 2010 working an average of 30 hours per week.

Using the 2010 numbers the cost of providing a <u>flat</u> \$3.00 per hour increase across the entire LDC sector would be approximately \$320 million in the first year.

This estimate does not include:

- any sector growth through 2010 2013
- proportional increases across the classification scale.
- changes in the number of hours worked since 2010; and
- changes in profile of the workforce profile as result of improving qualification requirements
