

Dear Senate Committee,

The creation of an Integrity Commission at a National level is welcomed, however citizens are sceptical of the political cartels to actually self regulate through commissions or any other apparatus designed by themselves. Let the Senate Committee learn from the lessons in Queensland.

The State counterpart, the CMC, was set up to investigate corrupt politicians and public servants by the post Jo politicians to attempt to appease the people by allowing them someone other than the courts to complain to. Courts cost money, especially costs orders by corrupt judges and magistrates.

Since the creation of the CMC, the people of Queensland were under the misguided belief that they were now safe from the corrupt political cartels, until of course the reporting requirements proved that the people were not safe.
