Thank you for the opportunity to provide a submission to the Senate Standing Committee on Community Affairs Inquiry into Palliative Care in Australia. My recommendations relating to the Inquiry are below.

1. National Directions in Palliative Care by Australian Government

The "National Palliative Care Strategy: 2010 Supporting Australian to Live well at the End of Life" (2011) was endorsed by the Australian Health Ministers Conference (AHMC). The implementation of the strategy is overseen by the inter jurisdictional Palliative Care Working Group (PCWG) which became part of the AHMAC Committee structure in 2011.

The National Palliative Care Program (NPCP) recognises flexible services for all Australians. Support is offered via community support for patients, families carers, palliative care drugs, workforce education, training. research and quality improvement. The Australian government also provides financial assistance to States and Territories to operate palliative care, a form of sub-acute care, through the National Partnership Agreement on Hospital and Health Workforce Reform (NPA HHWR) (Department of Health and Ageing, 2012)¹.

Through NPCP, the Federal government has funded, *inter alia*, Guidelines for residential and community aged care. The government has published "Guidelines for a Palliative Approach in Residential Aged Care" (APRAC Guidelines) (2011) and funded the development of training resources to assist staff. The other resource is "Guidelines for a Palliative Approach for Aged Care in the Community Care Setting" (COMPAC guidelines). Both Guidelines are approved by the NHMRC. The government is developing an education and training package for health personnel (GPs nurses, care workers) to assist them in using these guidelines. An external evaluation of NPCP projects will be completed in 2012-13 (Department of Health and Ageing, 2012)¹.

The Government supports Palliative Care Australia (PCA) under the NPCP to develop and implement standards to improve service quality. The "Standards for Providing Quality Palliative Care for all Australian" (the PCA Standards) were revised in 2005. These standards can be used in conjunction with, or as part of, service accreditation of bodies such as the ACHS Equip, Quality Improvement Council, RACGPs, or Aged Care Accreditation Standards. PCA was funded to undertake National Standards Assessments Program (NSAP) in 2007. There has been a national roll out for NSAP and currently there are 161 participating services.

The National Framework for Advance Care Directives (2011) is AHMC's work to assist States and Territories policy makers and planners. There are guidelines for advanced care directives and end of life medical decisions by health professionals (Department of Health and Ageing, 2012) ¹.

2. Stakeholder concerns about Clinical Practice Guidelines and staff training

Several stakeholders expressed concern at the public hearings for this inquiry about the need for improved staff training. mechanisms to facilitate care across the continuum and improved advanced care directives. They argued for updated Clinical Practice Guidelines in several areas relating to palliative care, standardised advanced care directives, timely diagnosis especially for dementia, pain management and improved case management to facilitate more cost effective service provision.

3. Clinical Practice Guidelines for Palliative Care

Recommendations

- 1. That the Department of Health and Ageing, relevant bodies of Council of Australian Governments (COAG) and NHMRC consider as a very high priority the update of a broad range of existing Clinical Practice Guidelines (CPGs) for palliative care and identify <u>additional</u> CPGs that are required for palliative care, as identified by the stakeholders at the public hearings of this inquiry.
- 2. In the review of current CPGs and identification of need for new CPGs, careful consideration to be given to existing international guidelines including, *inter alia*, the six attached to this submission by the National Institute for Health and Clinical Excellence (NICE) and the USA Department of Health and Human Services, Agency for Healthcare Research and Quality (AHRQ) National Guideline Clearinghouse.
- 3. To facilitate a thorough review by the NHMRC, COAG bodies and Department of Health and Ageing on the need for additional CPGs, careful consideration to be given to the extensive range of clinical effectiveness and cost effectiveness literature on interventions and treatment

modalities available in the Evidence Based Medicine literature and in accordance with NHMRC methodologies.
