
IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY NOT BE RATIFIED.
WE DO NOT SUPPORT THE WORLD TRADE ORGANIZATION, OR ANY OTHER ARM OF THE
NEW WORLD ORDER . WE SUPPORT TRADE WITHOUT CONTROL . AUSTRALIA SHOULD NOT
BE PARTY TO ANY AGREEMENT AS MENTIONED IN COSTS , PARAGRAPH 16. TREATIES
INVOLVING THE NEW WORLD ORDER IS NOT IN AUSTRALIAN INTERESTS, WE SHOULD BE
SOVEREIGN AND NOT PARTY TO ANY AGREEMENTS THAT WILL PLACE OBLIGATIONS ON
THE AUSTRALIAN PEOPLE WHO ARE THE REAL GOVERNMENT. THE CONCEPT OF THE NEW
WORLD ORDER IS AS OLD AS MAN , WE CANNOT BE CONTROLLED ACCORDING TO THE
AUSTRALIAN CONSTITUTION , FOR THAT WHICH CONTROLS WOULD BE SOVEREIGN. THE
SOVEREIGNTY RIGHT, RESTS WITH THE PEOPLE (QUICK & GARREN) AUTHORS OF THE
FEDERAL CONSTITUTION 1900 . INTERNATIONAL CONTROL IS EVIL . ADOLF HITLER AND
JOSEPH STALIN WANTED A NEW WORLD ORDER, THE FABIAN SOCIALISTS (LABOR PARTY)
ALSO BELIEVE IN FOREIGN CONTROL . SOCIALISM SHOULD BE NATIONAL , AND NOT THE
