JOINT STANDING COMMITTEE
ON TREATIES . RE : TREATY
BETWEEN AUST .& FEDERAL
REPUBLIC OF GERMANY ON
SOCIAL SECURITY.

DEAR SIRs.

IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY NOT BE RATIFIED . WE DO NOT SUPPORT THE PAYMENT OF WELFARE OUTSIDE OF AUSTRALIA . IT IS OUR POLICY THAT ANY AUSTRALIAN CITIZEN BE ABLE TO SUPPORT THEMSELVES IF THEY ARE NOT WORKING OR RETURN TO AUSTRALIA TO LIVE . PEOPLE WHO BECOME AN AUSTRALIAN CITIZEN THEN RETURN BACK TO THE COUNTRY OF ORIGIN SHOULD LOSE CITIZENSHIP RIGHTS OF AUSTRALIA . BECAUSE OF VALUE DIFFERENCE IN CURRENCY IN OTHER COUNTRIES , THESE PEOPLE WOULD SOON BECOME WEALTHY . THIS PRACTICE SHOULD STOP . WE CANNOT FEED THE WORLD OR NOR WE SHOULD . IF RESIDENTS FROM OTHER NATIONS COME TO AUSTRALIA AND CANNOT SUPPORT THEMSELVES FOR A PERIOD OF FIVE YEARS THEN WE SHOULD RETURN THEM TO THEIR COUNTRY OF ORIGIN AS SOON AS POSSIBLE , THEN RECOVER COSTS FROM THE FOREIGN GOVERNMENT . THIS NATION CANNOT BE A CHARITY , THE EXECUTIVE POLICY EXTENDS TO ALL NATIONS , IT IS NOT AIMED AT ONE NATION . A GREEN CARD SHOULD ONLY BE ISSUED FOR WORK AND SOCIAL SECURITY PAYMENTS AFTER FIVE YEARS . THE EXECUTIVE WISH TO THANK THE COMMITTEE FOR ALLOWING US TO COMMENT ON THIS TREATY .
