DEAR SIRs.

IT IS THE SUBMISSION OF THE EXECUTIVE THAT THIS TREATY BE RATIFIED AS OUR NATIONAL CARRIER QANTAS HAS THE BEST AIR SAFETY RECORD IN THE WORLD , WE SUPPORT ANY EFFORT TO EXTEND THAT RECORD TO OTHER AIRLINES .


