DEAR SIRs.


IT IS THE SUBMISSION OF THE EXECUTIVE THAT THIS TREATY NOT BE RATIFIED. WE DO NOT SUPPORT THE NEW WORLD ORDER , NOR THE CONCEPT OF THE IMF OR THE WORLD BANK. MAYER AMCHEL ROTHSCHILD STATED IN 1760 ,QUOTE . GIVE ME THE POWER TO ISSUE MONEY AND I CARE NOT WHO RUNS GOVERNMENTS. MAYER AMCHEL ROTHSCHILD CREATED BANKING CONTROL OF THE WORLDS ECONOMIES BY USURY.
