DEAR SIR.


IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY BE RATIFIED,
THE AUSTRALIAN PATRIOT MOVEMENT NATIONAL EXECUTIVE BELIEVE IN TOTAL
EQUALITY FOR ALL AUSTRALIANS , IN ALL FORMS . WE SUPPORT EQUAL WAGES
FOR WOMEN IN THE WORK PLACE . ALL FORMS OF DISCRIMINATION AGAINST
WOMEN SHOULD BE AN OFFENCE UNDER FEDERAL LAW. THE EXECUTIVE DO NOT
HOWEVER BELIEVE THAT A TREATY WILL ENSURE THAT DISCRIMINATION OF ALL
WOMEN WILL CEASE , EDUCATION, ENFORCEABLE LAWS ARE TO US THE ONLY
SOLUTION TO ENSURE EQUALITY . SECTION 6 OF THE PROTOCOL STATES THAT A
PERSON CAN COMPLAIN TO THE UN COMMITTEE AFTER THEY HAVE EXHAUSTED
ALL DOMESTIC AVENUES , BY THE TIME PEOPLE EXHAUST ALL DOMESTIC THEY
NO LONGER WANT TO PROCEED WITH FURTHER ACTION. PEOPLE WANT A SIMPLE
SOLUTION TO PROBLEMS , OUR LEGAL SYSTEM SHOULD PROVIDE SOLUTIONS NOT
TO PAWN OFF PROBLEMS TO THE UNITED NATIONS. MENTION IS MADE OF THE
IMPLEMENTATION OF INTERNATIONAL LAW, MEMBERS OF THIS EXECUTIVE HAVE
BEEN INFORMED BY LOCAL COURTS THAT THEY ARE NOT INTERESTED IN THE
IMPLEMENTATION OF INTERNATIONAL LAW , THE COURTS STATE THAT THEY ARE
SOVEREIGN. THE LEGAL SYSTEM DO NOT RECOGNISE FEDERAL LAWS , NOR DO
