DEAR SIRs.


IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY SHOULD NOT BE RATIFIED. WE SUPPORT THE TAXATION SYSTEM BUT WE CANNOT ACCEPT THE INVOLVEMENT OF THE AUSTRALIAN TAX OFFICE (ATO). THE TAX OFFICE ADMITS THAT IT IS NOT A LEGAL ENTITY, THERE FOR IT CANNOT BE A PARTY TO AN INTERNATIONAL TREATY. WE THE EXECUTIVE CALL ON THE PARLIAMENT TO PLACE ALL TAXATION UNDER TREASURY AND ABOLISH THE ATO. WE DO NOT ACCEPT THAT MULTINATIONALS CAN AVOID TAXATION ON PROFITS, A TRANSACTION DEBIT TAX SHOULD BE INTRODUCED OF ONE PER CENT ON ALL TRANSACTIONS. FOREIGN AID, FOREIGN DEBT PAYMENTS SHOULD CEASE AND THE MONEY SPENT ON AUSTRALIANS. MILITARY EQUIPMENT SHOULD BE MADE IN AUSTRALIA AND THERE WOULD BE EMPLOYMENT CREATED, A SAVING ON CONTRACT PRICES.
