## Committee in final stages of biodiversity inquiry

The House Committee on Climate Change, Environment and the Arts is holding a public hearing in Canberra on 12 October as part of its inquiry into Australia's biodiversity in a changing climate. Having completed its interstate hearings and site inspections, the Committee is now conducting final hearings in Canberra.

The Committee will discuss issues that have arisen throughout the inquiry, including natural resource management and the move towards adaptive management, wildlife corridors and connectivity projects, research funding priorities and programs, policies to manage invasive species and species decline, and community awareness and education projects.

Evidence will be given on research funding by the Australian Research Council and the Department of Industry, Innovation, Science, Research and Tertiary Education. The Committee will also hear from the Great Barrier Reef Marine Park Authority on the state of the Reef's coral cover, as well as on its Reef Guardian program. The Chair of the National Wildlife Corridors Plan Advisory Group will update the Committee on the status and content of the Draft Plan, and the Department of Sustainability, Environment, Water, Population and Communities will discuss the government's approach to managing biodiversity in an uncertain climatic future.

Committee Chair, Tony Zappia, said that 'the Committee is looking forward to discussing the issues that have arisen throughout the inquiry, including Australia's research priorities and the National Wildlife Corridors Plan, and giving the government departments an opportunity to address these and other issues.'
