ACT OR ACTS SHOULD BE SENT TO PRISON FOR LIFE WITHOUT PAROLE.

ACT OF DISAGREEMENT WITH LAWS BY PEACEFUL MEANS AS AN ACT OF THIS
TREATY DEFINING TERRORISM.
