INQUIRY INTO CHILD CUSTODY ARRANGEMENTS
IN THE EVENT OF FAMILY SEPERATION.

POINT ①

IN A SITUATION WHERE BOTH PARENTS HAVE A DESIRE AND
CAPABILITY OF SHARING EQUAL RESIDENCY AND ARE CONSIDERED
FIT AND PROPER PERSONS -


THAT EQUAL JOINT RESIDENCY BE FIRST POINT OF LAW.
IF HOWEVER THIS IS NOT FEASIBLE OR PRACTICAL DUE TO
LIFE STYLE RE-ADJUSTMENT OF SEPERATED PARENTS, THAT
PARENTS IF POSSIBLE MAKE MUTUALLY AGREED ARRANGMENTS IN
CONSIDERATION OF CHILD/REN BEST INTREST, SIGNED OFF BY FAMILY LAW.
ALTERNATIVLY WHERE CONFLICT EXISTS RESALUTION SHOULD BE
DETERMANED BY FAMILY LAW BODY, IN THE BEST INTREST OF
CHILD/REN.

POINT ② IN PARTICULAR INTREST OF CHILD/RENS WELFARE.

THAT NEW PARTNER/S OF PARENTS WHOM MAY BE IN RESIDENCE
OR TRUSTED COMPANY PART OR FULL TIME OF CHILDREN BE NETTED
TO CONSIDERATION OF FIT AND PROPER PERSON, AND IF FOUND TO BE
NOT FIT AND PROPER PERSON THAT AT MINIMUM A COURT ORDER BE PLACED
TO EFFECT THAT PERSON/S NOT BE ALLOWGN ALONE AT ANYTIME WITH CHILD/REN.

NOTE:- HIGHEST RATE OF CHILD ABUSE IS PERPATRATED BY PEOPLE
INTRAUSTED IN CHILD/RENS COMPANY AND IN PARTICULAR NON BIOLOGICAL
PARENT/PARTNER OF RESIDENTIAL BIOLOGICAL PARENT.

CHILD SUPPORT RECOMENDATION

RECOMENDATION - THAT ALL DEPENDANT CHILDREN BE ALLOWEN SET MINIMUM AMOUNT.

EXAMPLE - ONE CHILD	\$100-00
TWO CHILDREN	160-00
THREE CHILDREN	180-00

BASED ON SLIDING SCALE OF SHARED EXPENSES.

ALLOWING ALL OTHER GOVERNMENT DEPENDANT AUSTRALIAN CITIZENS ARE DEEMED TO REQUIRE MINIMUM SET FIGURE TO SUBSTAIN A MINIMUM STANDARD OF LIVING.

I.E.

SINGLE/MARRIED WITH/OUT CHILDREN	}	UNEMPLOYED
		INVALIDE
		ACED
		CARER

CHILDREN ARE CURRENTLY SUBJECTED TO VARIATIONS RANGING FROM \$21-50⁹ PER MONTH TO SEVERAL HUNDRED DOLLARS PER WEEK.

SET FIGURE -

COULD BE DETERMINED AND PAYMENT AMOUNT CALCULATED THUS.

PAYING PARENT DEEMED TO BE ABLE TO PAY FULL AMOUNT SHOULD DO SO.

USING EXAMPLE OF \$100-00 PER WEEK ONE CHILD.

LOW INCOME PAYING PARENT DEEMED TO BE ABLE TO PAY \$80-00 PER WEEK WOULD HAVE \$20. CONTRIBUTION FROM GOVERNMENT FUNDS

EXPECTED RESULT - PAYING PARENT REMAINS IN WORKFORCE CONTRIBUTING A GREATER FIGURE THAN \$21-50⁹ PER MONTH FROM SELF GENERATED FUNDS AND REMAINS IN WORK FORCE AS TAX CONTRIBUTOR SELF FUNDED.

TAKING INTO ACCOUNT GOVERNMENT CURRENTLY TOPS UP LOW INCOME FAMILIES TO INSURE NO AUSTRALIAN CHILD LIVES IN POVERTY.
