1 SUICIDES IN AUSTRALIA EXCEED
60 PER WEEK, OF WHICH
10 PER WEEK ARE THROUGH RELATIONSHIP
BREAKDOWNS WITH LOSS OF CHILD CONTACT.

2 THE CHILD SUPPORT AGENCY (CSA)
CAUSES MANY DISPUTES BETWEEN
PARENTS, BY ADVISING MOTHERS NOT
TO ALLOW SLEEPOVERS EXCEEDING 10 NIGHT
(AS IN MY CASE) TELLING THEM THAT
THEIR MAINTENANCE CAN BE REDUCED,
AND PROBABLY WILL BE, WHICH IS
AN INCORRECT ASSUMPTION!

MY SLEEPOVERS WERE STOPPED 100%
ON THIS ADVICE, SO I SENT WARNING
LETTERS RE: CONTRAVENTION OF CHILD ORDER
FOR 3 MONTHS, BEFORE TAKING COURT
ACTION, WHICH WAS LATER COUNTER-
ATTACKED WITH A VIOLENCE ORDER
(NON-PHYSICAL) IN RETALIATION (LIES!
(SEE SEPERATE LETTER TO S.A. PREMIER)

DVRO CLAIMING ME A VIOLENT PERSON,
WITH CUSTODY OF A 9 YEAR OLD GIRL
8 NIGHTS AT A TIME UNDER FAMILY COURT

4 Do you REALLY BELIEVE THIS LITTLE GIRLS 'DADDY' IS A VIOLENT PERSON?

TRY ASKING HER! FOR THE TRUTH!

5 DOMESTIC VIOLENCE IMPLIES 'BEWARE', IT SHOULD BE CATERGORIZED INTO

(a) DOMESTIC 'PHYSICAL' VIOLENCE AND

(b) DOMESTIC 'VIOLENCE OF THE TONGUE'

A CHARGE LAID ON AN ARGENTINIAN PLAYER IN 1966 WORLD CUP (FOOTBALL),

AS IN COLLOQUIAL SPEECH - 'TONGUE LASHING'

GIRL IS PUT IN CHILD CARE WHILE MOTHER WORKS!

7 ADVANCEMENT IS PREVENTED IN WORK, BY CSA EXPECTING MORE MAINTENANCE — IT SHOULD BE FIXED AT SEPERATION! (NO PAY, NO PA) SO BOTH CAN 'GET A LIFE' AND START AGAIN AFTER PAYING RENTAL MANAGERS — COUNCIL RATES — BUILDING MAINTENANCE TEAMS, AND MANY OTHER EMPLOYEES, I'VE CANCELLED ALL THEIR CONTRACTS AND AM SELLING MY BUSINESS, RATHER THAN PAY EXTRA MAINTENANCE TO CSA, EVEN THOUGH THE BANKS HAVE PLEADED WITH ME TO EXPAND MY SUCCESS!
