
IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS TREATY

DEAR SIRs.

IT IS THE SUBMISSION OF THIS EXECUTIVE THAT THIS  
TREATY BE RATIFIED.

HOWEVER WE DO NOT BELIEVE THAT WITHOUT A LARGE

AS STATED THESE CRIMINALS ARE ORGANIZED, ALSO THE

ARE EXPERTS IN DRUGS , TREATIES ARE ONLY AGREEMENTS , ANYTHING  
ON PAPER LOOKS GOOD.

FEDERAL AGENTS , SUCH AS THE AMERICAN F.B.I IS WHAT  
IS NEEDED IN AUSTRALIA. RECRUITMENT AND FUNDING FOR A FORCE

STATE COURTS SHOULD HAVE NO AUTHORITY, ALSO STATE POLICE SHOULD HAND OVER ANY OFFENDER TO FEDERAL AGENTS , FOR PROSECUTION , UNLESS THE FEDERAL COURTS BECOME PART OF THE FIGHT , AND POLITICANS LET THE FEDERAL AUTHORITIES DO THE JOB THEN THIS TREATY IS NOT WORTH THE PAPER IT IS WRITTEN ON.

AS THIS EXECUTIVE HAS STATED , BECAUSE OF THE SIZE OF AUSTRALIA AND A SMALL FEDERAL LAW ENFORCEMENT BODY , THEN TO BE EFFECTIVE IT MUST GET FUNDING AND NON INTERVENTION BY PARLIAMENTS.

THIS EXECUTIVE HAS INCLUDED SUBMISSIONS ON PEOPLE SMUGGLING, AND THE UNITED NATIONS CONVENTION AGAINST TRANSNATIONAL ORGANISED CRIME, IN THIS SUBMISSION.

AS THESE TREATIES ARE LINKED BY THE FIGHT AGAINST CRIME, THIS EXECUTIVE DOES NOT SUPPORT THE HOLLYWOOD IMAGE OF THE SO CALLED MAFIA , BEING THE ONLY ORGANIZED CRIME GROUP , AUSTRALIA HAS ITS OWN PROSTITUTION RING , OF ORGANIZED CRIMINALS . GAMBLING , DRUGS , AS WELL AS ASIAN , SOUTH AMERICANS, RUSSIANS , IN MOST ETHNIC GROUPS HAVE AN ORGANIZED CRIMINAL ELEMENT.

IN MAJOR AUSTRALIAN CITIES WOMEN ARE SENT AROUND THE NATION WHO ARE PROSTITUTES , BY ORGANIZED CRIMINALS.

THESE CRIMINALS ARE AUSTRALIANS , NOT ASIANS , OR AMERICAN MAFIA . UNLESS A SERIOUS ATTEMPT IS MADE BY THE PARLIAMENT TO REALLY COMBAT ORGANIZED CRIME THEN ALL TREATIES SUCH AS THESE TREATIES ARE WORTHLESS.

WEAPONS ARE A MAJOR SOURCE OF INCOME , ALONG WITH DRUGS , AND GAMBLING , TO ORGANIZED CRIME . THESE PEOPLE CAN AFFORD TO SHUT DOWN OPERATIONS IN ONE FIELD , IF LAW ENFORCEMENT GETS TO CLOSE.

ANOTHER PROBLEM THIS EXECUTIVE WISHES TO POINT OUT IS THE ONE OF DISHONEST ENFORCEMENT OFFICERS , WORKING WITH ORGANIZED CRIMINALS,

OUR COURTS HAVE A RECORD IN HANDING SENTENCES WHICH ARE A JOKE , OUR LEGAL SYSTEM NEEDS AN OVERHAUL .

SHAM MARRIAGES TO MIGRANTS LIVING OVERSEAS , SO THEY CAN ENTER AUSTRALIA , IS ALSO A RACKET BY ORGANIZED CRIME.

MONEY LAUNDERING , BECAUSE OF TAXATION AGREEMENTS WHICH ENABLE CRIMINALS TO USE MULTINATIONAL TAX AVOIDENCE LAWS , PUT IN PLACE BY OUR OWN PARLIAMENTS , HELP MONEY LAUNDERING EXIST. CRIMINAL ACTIVITY IS IN EVERY PART OF AUSTRALIAN SOCIETY.

COST IMPLICATIONS, IS A MAJOR CONCERN TO THIS EXECUTIVE, IT IS OUR OPINION THAT COSTS BE MET BY THE INDUSTRY, NOT THE AUSTRALIAN TAXPAYER.

AS MULTINATIONALS DO NOT PAY TAX ON PROFITS, DUE TAX AGREEMENTS UNDER AUSTRALIAN LAW, THEN THIS EXECUTIVE BELIEVE THAT THEY SHOULD PAY THE COSTS INVOLVED BY AUSTRALIA.

ALSO AS THE SHIPPING THAT WOULD BE MOST AFFECTED BY THIS TREATY, AND THE DANGER TO OUR COASTLINE WOULD BE THOSE OWNED BY MULTINATIONALS, THEN THEY SHOULD BE EXPECTED TO BEAR THE COSTS.
