Irrigation and environmental groups to discuss Water Special Account Bill

The Water Amendment (Water for the Environment Special Account) Bill establishes a \$1.77 billion special account for infrastructure improvement projects that seek to improve water efficiency in the Murray-Darling Basin. The funds for the account are to be appropriated over the next ten years.

The House of Representatives Standing Committee on Regional Australia will hold a public hearing into the Bill tomorrow in Sydney. Mr Tony Windsor, Chair of the Committee said 'The Committee has previously recommended to the Government that funds be dedicated to improving on-farm and off-farm infrastructure that lead to greater water efficiency. It is pleasing to see the Government acting upon this recommendation'.

'However, the community has raised important questions about the operation of Bill that the Committee needs to explore.' said Mr Windsor.
