	I am a lead spokeswoman for Advance's Fair Australia campaign against a constitutionally enshrined Voice and regularly speak at events organised by Advance Australia. On occasion, modest expenses for my attendance at these may be covered by Advance, including my participation in the recent "No" speaking tour where I spoke at events in Perth, Adelaide and Sydney between 25 April - 6 May 2023.
